## 1992 ride season in full swing

### Anasazi "B" Ride – April 12, 1992

**W**ho would think of having a trail ride in northwest New Mexico in the middle of April? Why, the chances of the weather being good would seem to very slim. If there was a ride, who would think of entering it? Well, the folks in Farmington, New Mex., decided to hold a clinic Apr. 11, 1992, and have a subsequent B ride the next day, Apr. 12.

The ride was named Anasazi since the Anasazi Indians had come to the area long before the Navajo. There were 57 riders signed up to ride and all 57 checked in, including 13 first-time riders. The weather was great as 55 riders started on the trail Sunday morning with all 55 completing.

The open class was light in turnout, but there were 19 novice heavyweight, 13 novice lightweight and eight novice juniors. First-time rider Rex Moore's horse Barney took first place in novice heavyweight and Bill Smith took the first-time rider award. – *Nola Frasure*

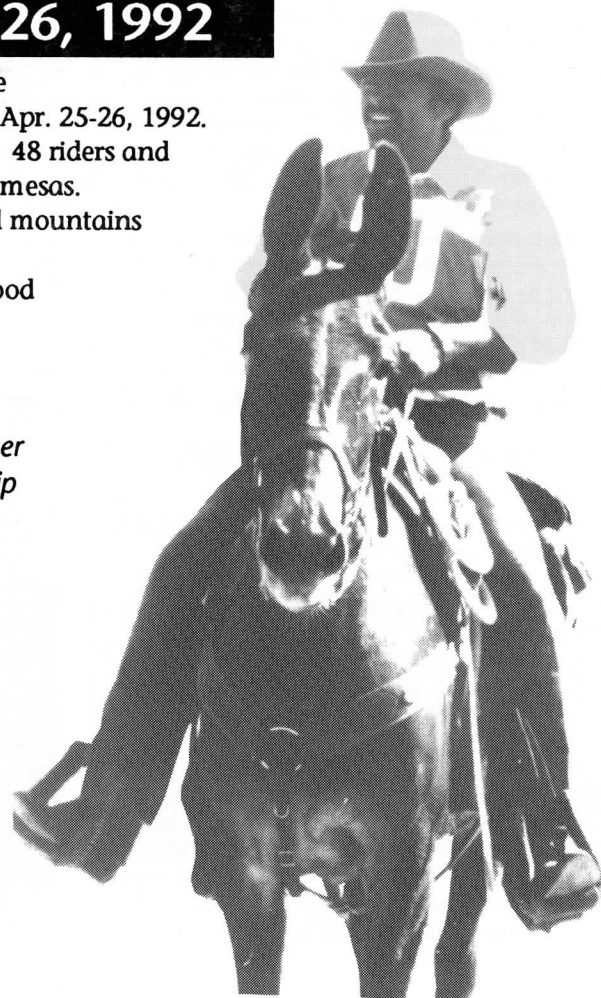

## Navajo Lake Ride – May 9-10, 1992

The Navajo Lake ride, held on Mother's Day weekend, was another lesson as to why you should not open a ride after a limit has been set. With the 60 rider limit filled by Apr. 17, and a waiting list of 14 riders (at one point in time) Saturday morning saw only 55 riders start with 51 completing the ride.

Mother Nature was a little fickle with the weather. Saturday was windy with a few scattered showers, but she really pulled the plug out at about 6:30 p.m. A few tent campers spent a cramped night in their vehicles and others spent a sleepless night loading and unloading horses in trailers. As one rider put it, "As soon as I would get the horse loaded, the rain would stop. When I unloaded, the rain would start." Sunday morning dawned a little cool, but with a little wind to help dry things out. The trail was changed and the timing to match, and the ride went on.

### Veteran horses finish high

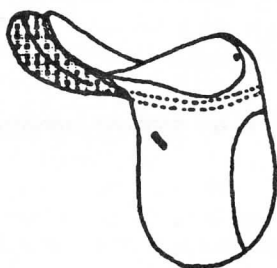

## BITS AND PIECES

### Region 3 renewal/newsletter subscription

If you haven't renewed your Region 3 membership, the cutoff date for receiving the *Region Three Newsletter* will be June 1 of the same year. National (but not Region 3) members will receive two complementary newsletters only unless they join Region 3.

### Eligibility for Region 3 year-end awards

All national NATRC members who are dues-paying members to Region 3 NATRC are eligible for regional placings and awards.

#### Requirements:

Open horses and riders must enter three (3) rides per season and accumulate a minimum of 30 points to be eligible for year-end placings. Open horses and riders will be eligible for the Ruth Tyree High Average Horsemanship and Ken Burkdoll Combined High Average Horse/Rider awards if they enter a minimum of six (6) regional rides. All rides started will be counted.

Competitive Pleasure horses and riders must enter two (2) rides per season and accumulate a minimum of 20 points to be eligible for year-end placings. Competitive Pleasure horses and riders will be eligible to compete for the High Average Combined Horse/Rider award but must enter a minimum of four (4) rides per season. The top horse in Competitive Pleasure shall be considered as a sweepstakes horse within the class and shall receive 2 additional points as done in the Open and Novice divisions. Novice horses and riders must enter two (2) rides per season and accumulate a minimum of 12 points to be eligible for year-end awards.

Horses and riders receive 4 points for ride completion and a sweepstakes horse receives 2 points (18).

### Memo to ride managers

Rides are requested to send the results of a ride to national within two weeks after the ride. Ride results Region 3 rider fees should be sent at the same time to the point chairman.

### Verification of points and mileage

The point secretary keeps all Region 3 members' points and mileage each year. You are welcome to verify your points with the chairman by Oct. 15 of the current year, otherwise you must accept the points as calculated by the point secretary. Region 3 NATRC members who have not renewed their memberships by June 1 of each year will have to pay an additional \$15 secretarial fee if they wish to have either their horse or rider points and mileage recorded. ### Breed award eligibility

To be eligible for breed awards at each ride, you must send in a copy of your horse's registration papers with the ride entry. This copy will be returned to you the day of the ride.

After 10 miles of "do's and don'ts" concerning NATRC etiquette (i.e. obstacles, body position, trot-outs, etc.) . . . we all met back at the trailers for a final question and answer session. *Almost all of these participants have now signed up for at least one Region 3 ride this season, yea!*

*It's the law . . .*

## Brand inspections a must for all horse owners

**I**t's mind-boggling to know that one of the earliest laws established in the territory now known as the State of Colorado has been so blatantly bypassed in recent years through ignorance and/or negligence. This law falls under the State Board of Stock Inspection (SBSI) Commissioners, a branch of the Department of Agriculture. Its sole purpose is to protect those in the state's livestock industry whether it be horses, mules, donkeys or cattle. The brand board is made up of active members of the livestock industry. "The brand laws are actually the livestock industry governing itself," Denver brand inspector Lee Painter said. Employees of the SBSI are charged with the monstrous task of keeping track of all stock entering and leaving the state, transferring ownership on animals within Colorado or from another state as well as taking care of all missing, strayed and stolen livestock. This job becomes all the more complicated when horse owners, etc. do not follow proper procedure when buying, selling or transporting their steeds.

Remember, inspection is required regardless of whether or not the animal is branded and registration papers or lack of registry does not exempt inspection. According to Painter, "Just because your horse's papers show you as the owner, it does not constitute legal title or compliance with Colorado brand laws. Registration papers must be accompanied by a brand certificate in order to be in compliance with the laws, and lack of an inspection can constitute criminal charges," he added.



If you've purchased a horse in a state other than Colorado, check for that state's requirement concerning inspection prior to the purchase and transport back to Colorado. Several states do not have an inspection law, so to prove your ownership of animals coming from one of these states, a **legal bill of sale** should include: the seller's name, what town and state the horse came from, a complete description of stock purchased (color, sex, breed, registration number [if any], markings, etc.), the signatures of buyer and seller and the signature of a third party where the transaction took place.

There are Colorado brand inspectors available throughout the state and the cost for an inspection is surprisingly low. Horse owners are charged \$7.50 for the service call and 34 cents per horse per inspection fee. If you want a Permanent Travel Card for horses you plan to keep or trailer to trails, etc., the charge for the card is \$10 per horse.

For such a nominal fee to abide by the law, the consequences for not complying are high. If you are stopped by the Colorado State Patrol and cannot produce proper brand inspection papers, the trooper checking you can fine you \$200 or more per horse.

To schedule an inspection or for further information, call the SBSI office at (303) 294-0895. By helping them, you will be helping yourself. — Stacy Bowman

### To operate legally as a responsible Colorado horse owner, the following regulations must be followed:

- An inspection is required every time an animal is sold or purchased (horses, donkeys, mules and cattle) or when any change of ownership occurs, regardless of whether or not the animal is transported after or prior to the sale;
- An inspection is required when livestock is to be transported over 75 miles totally within the boundaries of Colorado or leaving the state. These two items may be accomplished by the owner obtaining the "Permanent Travel Card" (for horses only). However, the Permanent Travel Card is only good for the current owner who obtained the card – it cannot be transferred onto a new owner. The new owner has to have to obtain his/her own card by simply contacting the local brand inspector;
- Any time livestock is to be transported on a public road, proof of ownership should be available for inspection by the Colorado State Patrol, local law enforcement or a brand inspector;
- Animals being transported by anyone other than the legal owner should have a letter from that owner authorizing the transport in conjunction with the inspection certificate;
- Any livestock crossing a state line must be accompanied by a current health certificate. Contact your veterinarian or the state veterinarian's office at (303) 866-2829 (in Colorado) for more specific information. A negative Coggins test is also required when hauling horses across state lines.




# New Commercial Drivers License law clarified

With all of the confusion about the new Commercial Drivers License (CDL) law, here are three facts:

1. This law only applies to commercial vehicles and their drivers. Commercial vehicles are defined as any vehicle with a Gross Vehicle Weight Rating (GVWR), or Gross Combined Weight Rating (truck and trailer), as issued by the vehicle manufacturer and indicated on the data plates, in excess of 10,000 lbs. and operated in commerce.

2. If you operate a commercial vehicle and it is within 100 air miles of your home/place of business, you must have a medical certificate, but not a log book. All commercial vehicle drivers must have a medical certificate regardless of the number of miles traveled. The only exception for this is an operator of a farm vehicle over 10,000 lbs. GVWR. If a farm vehicle owner remains within 150 air miles of the farm, they are not required to have a medical certificate, but if they travel beyond 100 air miles, they still must maintain a log book.

 *If you are in the horse business to make a profit,  
than you are classified as commercial.*

3. If the Gross Combined Weight Rating of the towing vehicle and trailer is in excess of 26,000 lbs. and the GVWR of the trailer is greater than 10,000 lbs., the operator must have a Class A CDL, a medical certificate and, if traveling beyond 100 air miles, a log book.

All Professional Rodeo Cowboys Association members who make their living riding the circuit are clearly classified as commercial. All vehicles with a GVWR of greater than 10,000 lbs. are considered commercial. If you are in the horse business to make a profit, you're considered commercial. – COHOCO Newsletter, Spring 1992

## Warning signs available

The Colorado Horseman's Council has 24 gauge steel warning signs which are 18" x 24", white baked enamel on both sides, with black lettering.

These signs should be placed wherever equine activities occur in order to notify the public that there are inherent risks involved with equine activities and participants cannot hold anyone liable for injuries that may occur from these risks.

The Equine Civil Liability Act went into effect July 1, 1990. Under it, an equine professional must post warning signs in clearly visible locations on or near stables, corrals or arenas where equine activities are conducted. The warning notice specified under the act must appear in black letters that are at least one inch high.

The cost of each sign is \$5.50 for COHOCO members (Region 3 is a member) and \$10.00 for non-members. A shipping fee will be added to the price. Contact Peggy or Dave Campbell at (303) 429-9739.

The Colorado Horseman's Council, representing many different facets of horse ownership, is making the following policy statement regarding horse care concerns in Colorado:

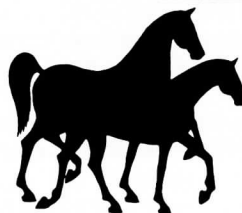
It is the responsibility of every horse owner in the state to ensure that proper care is taken of their horse(s) according to accepted methods of good equine husbandry, as set forth by the Colorado Department of Agriculture, i.e.

sufficient food and water in appropriate amounts to sustain health and well-being in all kinds of weather;

that shelter such as wind breaks and barns are in place when appropriate and needed;

that veterinary and farrier care are provided to sustain good health.

Training methods that are clearly cruel and inhumane are not acceptable and will not be tolerated in Colorado by responsible horse owners and horse associations. – COHOCO Newsletter, Spring 1992

# REGIONAL BOARD HIGHLIGHTS

The following is an abbreviated version of the minutes of the board of directors (BOD) meeting held May 2, 1992, in Dillon, Colo.

The meeting was called to order at 10:30 a.m. Board members/chairpersons present were Jill Talbot, Cindy Wright, Dean Schrader, Joyce Calhoun, Stacy Bowman, Frank Bowman, Susie Witter, Pat Jubb, Neal McKinstry, Laurie Butterfield, Lisa Sowell, Jan Thomas and Judy Miller. Minutes of Jan. 18, 1992 meeting were read then approved. Updated BOD list distributed, note Cindy McNamara is using the name Cindy Wright (no, she didn't get married . . .)

**Treasurer's Report (Joyce Calhoun):** copies of report distributed. Noted that figure for first aid kits seemed high, differing from Jill's records.

Joyce met with Ike Mosgrove and audited the accounts. The national board figure was a combination of the ride fees, 1991 balance.

General account very low for this time of year, looks better than it actually is. National gave Region 3 \$200 of this (\$100 for brochure, \$100 for ride book). National very impressed with ride book. General

and national fund money will be kept in same account to earn more interest but will be accounted for separately.

It was discovered that we have not been incorporated for four years, have been reinstated for \$125 fee, Joyce listed as trustee. This has to be renewed every two years to avoid unnecessary expense, \$10 renewal fee if kept current.

Noted if incorporation lapses, so does insurance. Region 3 does not have to file federally because we earn less than \$10,000/year. Tax ID number held by Jill and Joyce, can be used for copying expenses, etc. Pursuant to a government regulation 501-C4, Region 3 donations are not tax deductible, but donations to national NATRC (a 501C organization) are tax deductible (go figure . . .).

Discussion of when to pay national board the \$400 allotment for their hard work and expenses. Only partially covers expenses, \$5 of each Region 3 membership goes to this. Motion made to reimburse national BOD members at time of expense, approved. Motion to approve Joyce's excellent report, approved. Thanks for all the hard work and solving accounting headaches, Joyce!

**Membership (Ike Mosgrove, not present):** Jill distributed new membership list, will have another list, including addresses, soon. 58 of last year's 142 members have not renewed, including some judges and board members (you know who you are . . .). Noted that non-members who request information get a special letter that costs 75¢ to send.

**Region Three Newsletter/Hoofprint (Lisa Sowell):** Change made to ride schedule regarding Cavalier ride location, newsletter approximately 2/3 done. Will be applying for different bulk rate postage rate.

**Membership labels (Pat Militzer, not present):** Pat needs all ride's rider list from last year. Susie will send her the copies she has, note when paying for mailing lists, make check payable to NATRC Region 3, not to Pat herself.

**1992 Seminar (Mary Lou and Rick McManaman):** This year the seminar will be held in north Denver. Information regarding tentative agenda and lodging distributed. Holiday Inn Holidome North was approved as hotel site. Mary Lou would like suggestions for speakers. Suggestions were discussed including trails issues, training, chiropractor/acupuncturist and tour of Arabian Horse Trust.

**Colorado Trail Adoption (Kathryn Utke, not present):** Kathryn sends apologies for not being able to attend, her brother was getting married at her house that day. She forwarded a letter that if we are not willing to commit ourselves to our portion of the trail, then we should give it up to another group. Discussion of dates, Kathryn will send information to interested people, note will be made in newsletter.

**Clinic/ Publicity coordinators (Frank and Stacy Bowman):** Stacy showed articles she got in *Horsesheets* and *Foxtrotter* magazines. *Western Horseman* turned down stories, they have had a lot of NATRC stuff lately (can they do that?). National BOD members will take these to next meeting. Packets distributed to clinics, if clinics would like reimbursement, contact board.

Sharon Saare offered to share booth expenses at Stock Show. Maybe Region 3 could leave flyers at the COHOCO booth and various breed booths.

**Historian (Judy Tobias):** New album containing 1989-present. Clippings in separate archive box, and Judy added some personal stuff. No \$ needed, Judy Miller will add photos from Horsetooth Ride.

**Judges Coordinator (Susie Witter):** New vet judge moved to region, Dr. Jim Wright.

Letter sent to coordinator in Oklahoma where one person recruits the judges for all the rides, possible option. Suggestions on other ways to recruit judges. Susie had partial list of this year's judges for rides. Discussion of judges not chosen yet for various reasons. Care is being taken not to try not to use the same judge more than twice in same year, national has no opinion on this. Motion made to make Judge's Coordinator an official committee and that the chairperson would have the judges coordinated by the spring of each year, Susie will write a job description, approved.

oughly and consider making some changes for approval at next board meeting. Jill put in long hours updating bylaws, current as of Apr. 15. They need to be updated annually (by president) by spring of each year, including additions/deletions. This is made easier, thanks to Jill. Changes proposed: Article I, Sec. 15, delete "consecutive"; Article III, Sec. 6, leave in "90 days" to allow time for nominations to come in, etc. Also change "election" to "nominating". Note that there is no procedure for holding an election in the bylaws and doesn't say when elections are held; Article XI, Order of Business, Look at at next meeting and propose a different one; Standing Rules, #4, Add "and videos". Consider for next meeting.

**Safety Rider Program** (Jill Talbot): Safety Rider Guidelines passed around. Reviewed and comments have been made on documents and copies sent to ride managers, note Region 3 is behind other regions in this area. Many loopholes in system regarding lawsuits in case of accident. Most objections being made that safety rider leader be a Region 3 member. Note national having trouble with their insurance, policy not covering riders!

Dr. Dabbs has made up the human first aid kits, discussion of contents of kit, review needs to be made. Comments made about the adequacy of horse kits. Two expedition kits available, carried by the rear pair of each division's safety riders.

Three letters read from Kathie Hayes, Patti Embree and Jeannie Boettcher. Discussion of Safety Rider requirements, including minimum age, first aid training, P&R checks of Safety Rider's horses, waivers, etc. Jeannie pointed out that though she approved of the safety rider concept, she disagreed with other aspects. A dedicated group had served in this capacity over the past three years, and that first aid certification (costing \$25-35) was a good thing, but requiring membership (for the additional expense) was unfair. She pointed out that no other ride position requires membership. Jill Talbot contacted Jerry Davis, the leading member of the group, to clarify that these were only guidelines to be considered for approval next year. National's lawyer will be contacted for a legal point of view rather than make an arbitrary decision to protect the riders and their horses. Motion made to accept guidelines including changes above, and to require waivers of all ride personnel, approved.

national. Ariel Schrader is looking into buying a tent, hold on this idea. Jim Porter's report on buying a PA system determined that this would be too expensive. Ride management needs to inform riders better of briefings, etc. The Youth Manual was distributed to 4-H and Pony Club leaders, limited because of expense. Committee will need a new chair next year. Great job. Patti Embree forwarded some information for discussion: CP Sweepstakes award will be a combination award, problems with some riders being rude to P&R personnel at Rabbit Valley, plus other related P&R procedural problems. Discussion followed on P&R team training. Also need to work on a buddy system for new riders.

**This and that . . . comments that defied categorization**: Regarding the term "trail gear" in rule book, better description? Seems okay. Bring back Region 3 novice and open regional 4-H Pony Club year-end awards, had in the 1970's and didn't work, maybe next year. Discussion about joining American Trails Association, pass on it this year. The bylaw committee was eliminated. Keep money in Sue Bretag fund, not shift it into General fund. Jan Thomas is now an at-large member as is Judy Miller (not just past president). Kathie Hayes also at-large, all three until 1993. Discussion of insurance coverage at clinics and NATRC rides. NATRC insurance is \$90 for riders, covering attorney fees and liability, but not riders. Better job descriptions for Region Three positions. Upcoming national meeting in Denver Jul. 11, 1992. Members should be encouraged to attend. Possible trip to Central City the night before. Discussion of a letter sent to board from first time rider, suggestion of article on electrolytes put in newsletter and to send ride packets to first time riders ahead of time. Discussion about bringing back ride critique, Judy Miller will coordinate. Mainly meant for Region 3 management, but will go to judges if requested. Susie has the ribbons for national award winners.

**Next board meeting**: Aug. 22, 1992, in Boulder, Colo. at Judd and Linda Adams' house, starting at 10:00 a.m. Potluck barbecue dinner will follow, Jill will send out directions. *(Editor's note: since this meeting took place, the date of the board meeting has changed to Aug. 29, same location.)* - Respectfully submitted by Cindy Wright
