## Reflections

*From the State Trails Symposium*

**A**s a representative of Region III NATRC, I attended the State Trails Symposium Jun. 8-10 in Colorado Springs. I sat in on some interesting seminars, including one on Trails Activism and one on having trails without having to create them. The latter seminar discussed having trails we already use designated by government so that, if the area is developed, the trails will not be lost. This includes the "informal trails" that is, the short cut through the alley or the power line access we use to get from our house to the trail we ride regularly.

In thinking about that concept and the idea of preserving the trails, I think all of us need to consider that very seriously. No matter where we live and ride our horses, our trails are being lost to development. It is not only the trails used for competition, but the local trails we use every day. It behooves all of us to become "Trails Champions" for our own areas. No organization can do that for us. We are the beneficiaries of those trails, we must be their guardians.

### **We can be cooperative with other trail users.**

The other idea I came away with from the meeting stemmed from conversations I had with other trail users – bicyclists, hikers, etc. They all said pretty much the same thing – horses are strange or dangerous, or have such different requirements for trail use that it is difficult to share the trails with them. That tells me that equestrians haven't been doing a very good job in promoting trail use for horses and convincing people that we can get along with other trail users. So, what can we do?

We can be cooperative with other trail users. That can be as simple as being pleasant to the bicyclist we meet on the trail, or scattering our manure where we've parked instead of leaving a smelly, unsightly pile for a hiker to step in. We can work with our horses so that they are more trail-wise instead of blaming the other trail users if our horse spooks at them.

We can recognize that horses do cause damage to trails and try to mitigate that damage by not riding on a muddy trail where the hooves will cause big divots. We can pack out our trash and not tie

our horses to trees and damage them. We can join volunteer groups to do trail maintenance once in a while and build water bars to stop erosion. We can stay on marked trails and not create a new path for water to flow down. We can even get a group of friends together and pick up trash on our favorite trail one morning.

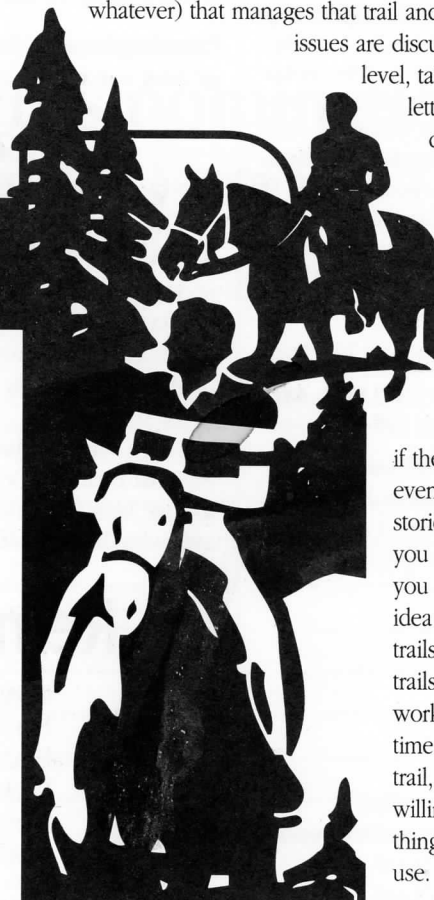
Most important, we can let people know we want trails and appreciate them. Among non-horsemen, there is a perception that all horse people only ride in arenas and go to horse shows. We need to change that perception. If you ride a trail that you particularly enjoy, call or write the local government group (parks department or whatever) that manages that trail and tell them so!! When trail issues are discussed at your city or county

level, take time to go, or write a letter expressing your

concern that horses be allowed on those trails.

And when your horse group has a trail ride or does some trail cleanup, send a press release to your local newspaper – even send photos if you have them. Call the local TV station and see

if they would cover a trail event. Most media love horse stories and photos. Each time you do something like this, you are helping to create the idea that horses do belong on trails and that horsemen want trails and that we are willing to work to have trails. The next time you ride your favorite trail, ask yourself if you are willing to do some of these things to preserve it for your use.

# McKelvy's Musings

**M**idsummer - Region III riders get a month-long break in competitions between El Jinete and Top of the World. Thank heavens for the recent rains which revitalized pastures and beat back the crispy conditions for the east slope of the Rockies. Fires remain a problem in many parts of our region. Evacuation plans and emergency preparedness is something to be considered for our equine companions. My hope is that none of us has to cope with a disastrous fire or climatic condition involving our households or horses.

Trails are a priority for our sport and I urge you to read the report on the State Trails symposium from Judi Tobias, Region III's trail representative.

Join Kathryn Utke's trail working crew on Aug. 6 near Copper Mountain to do needed trail maintenance on NATRC's segment of the Colorado Trail. Call Kathryn for details and directions. She promises to give riders a real conditioning work out!

During the Willow Springs B Ride, which takes place wholly on USFS lands in South Park, forest ranger Laurel Karren of the Pike National Forest office in Fairplay dropped by. She announced implementation of a noxious weed-free program within ALL national forests in Colorado, Utah, Montana, Nebraska, Wyoming and Idaho that will require horsemen using trails and camping in those states feed only certified noxious weed-free forage (pellets, hay, straw) to their mounts and pack horses. This program goes into effect on Sept. 1, 1994. Contact USFS offices at the following numbers for more information. Region III's rides this year are enjoying many new riders. We welcome them, especially the junior competitors. They are fresh, funny, revitalizing and winning respect and awards. So keep your skills honed and your horse in top condition during August. Get your ride entries in early for Top of the World and Golden Gate in September, and the Chokecherry, David B. Thomas and Peaceful Valley B Ride (near Elbert, Colo.) being worked up by Ed Boutte, in October.

## National Board Highlights

### Weight limitations change:

Proposal at national board to change "rider weight division" to "rider weight only" - no tack. Lightweight: 0 -160 lbs., Heavyweight: 161+ lbs. Or, just dropping the minimum of Lightweight so, Lightweight (with tack): 0-189 lbs., Heavyweight (with tack): 190+ lbs.

**Age limit for Junior riders:** The National Board is considering dropping the age limit for Juniors to eight years of age, with the possible restrictions of "must

ride with parent, legal guardian or sponsor." Novice Division only, and possibly, B Rides only.

In another item from the National Board, discussion was brought about to allow "drenching" of electrolytes. Drenching is considered to be forcefully administering electrolytes into the horse's mouth, usually with a syringe.

# REGIONAL BOARD HIGHLIGHTS

The following is an abbreviated version of the Region III board meeting, held May 6, 1994 at the BLM building, Navajo Lake, NM:

Present: Janine Ancell, Laurie Butterfield, Joyce Calhoun, Pat Jubb, Neal McKinstry, Sue McKelvy, Ike Mosgrove, Dee Overholt, Nancy Reinhardt, Dean Schrader and Susie Witter. Prior meeting minutes approved.

**Old Business:** Treasurer's Report from 1/1/94 - 5/4/94 approved. Region III made \$110 from sale of Troxel helmets, promotion will be continued. Region III also received \$350 from Ride Book advertising. The book was delayed because of family health problems and problems Sena had receiving all the information in time. Discussion followed about when the book should be ready and making deadlines to advertisers. It was decided that the priority will be to get the books out earlier rather than try to get more ads. Motion was made/passed to give Sena \$500 (plus expenses) for the book, and to have it out by March 15 if possible. The fee will come from the Bretag account as the book is a promotional item. Because of the early date, the Anasazi ride info should go into R3 Newsletter.

**Membership Report:** Ike Mosgrove reported 136 members in 1994 down 8 from last year. The membership list is changing to a book-type format, created by Joyce Calhoun.

Judy Miller is now assisting Pat Jubb with points, Susie Witter is no longer doing this. Motion made/ passed to ask Bill and Jenny Smith to host the Region



III seminar to be held in Farmington, NM in 1995. A change to the Standing Rules was passed: #7 changed to read "Elections of Directors shall be held and counted prior to the last meeting of the calendar year". The third sentence which reads "Ballots shall be..." will be eliminated. #1 changes as follows: Rider's fees shall be \$4.00 (not \$6.00 as shown) and \$1.00 of this shall go to the Region (not \$3.00 as shown). Sue McKelvy will make changes and turn over to Nancy to mail with Minutes. Neal McKinstry expressed concern over wording in By Laws for Article 7 Section 6 page 5 concerning removal from membership. It appeared only board members are given due

process as in Article 1 Section 4. Laurie Butterfield will ask Jeri Williams to review, will be tabled until next meeting. Motion was made/passed to keep Sue Bretag account maintained at a \$5,000 balance as its purpose is non money-making (promotional items) to keep it from becoming depleted.

**Colorado Trail Workday:** Discussion about approaching the Cavaliers Trail Riding Club to assist in trail repairs as we need all the help we can get. Neal said many drains need to be fixed and he will check with Katherine Utke. Ike will speak to the Cavaliers.

Region III has in possession one First Aid kit cantelebag created by Lovell Sasser. Motion made/passed to purchase one more. Discussion followed about the contents. Lois Arbour said it was lacking and needed arm slings, some medicines are out of date and that a medical doctor should review it annually. It was mentioned that Bill Smith sell kits that are refillable. A thank you note was received from Katty Wiese.

**New Business:** Sue asked for comments about issues concerning the southwest group and problems encountered in attending the winter meetings. The conference call solution was agreed upon as the best solution. One or two people could pool resources, get a speaker phone. The cost would be picked up by the non-attending members to replace travel and motel costs.

Discussion about selecting a Trails Committee liaison to represent us, as Region III need to take a more active role in this area. Sue will contact Judi Tobias who is already active with the Pikes Peak Trails Coalition, to see if she would do it. Motion made/passed for Region III to pay

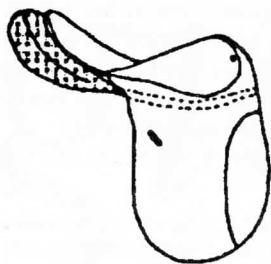

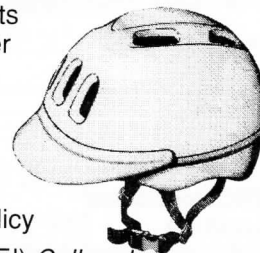

## BITS AND PIECES

### Region III renewal/newsletter subscription

If you haven't renewed your Region III membership, the cutoff date for receiving the **Region 3 Newsletter** will be June 1 of the same year. National members will only receive two complementary newsletters until they join Region III.

### Eligibility for Region III year-end awards

All national NATRC members who are dues-paying members to Region III NATRC are eligible for regional placings and awards. Requirements: Open horses and riders must enter three (3) rides per season and accumulate a minimum of 30 points to be eligible for year-end placings. Open horses and riders will be eligible for the Ruth Tyree High Average Horsemanship and Ken Burkdoll Combined High Average Horse/Rider awards if they enter a minimum of six (6) regional rides. All rides started will be counted. Competitive Pleasure horses and riders must enter two (2) rides per season and accumulate a minimum of 20 points to be eligible for year-end placings. Competitive Pleasure horses and riders will be eligible to compete for the High Average Combined Horse/Rider award but must enter a minimum of four (4) rides per season. The top horse in Competitive Pleasure shall be considered as a sweepstakes horse within the class and shall receive 2 additional points as done in the Open and Novice divisions. Novice horses and riders must enter two (2) rides per season and accumulate a minimum of 12 points to be eligible for year-end awards. Horses and riders receive 4 points for ride completion and a sweepstakes horse receives 2 points (18).

### Memo to ride managers

Rides are requested to send the results of a ride to national within two weeks after the ride. Region III rider fees should be sent at the same time to the point chairman.

### Verification of points and mileage

The point secretary keeps all Region III members' points and mileage each year. You are welcome to verify your points with the chairman by Oct. 15 of the current year, otherwise you must accept the points as calculated by the point secretary. Region III NATRC members who have not renewed their memberships by Mar. 1 of each year will have to pay an additional \$15 secretarial fee if they wish to have either their horse or rider points and mileage recorded. ### Breed award eligibility

To be eligible for breed awards at each ride, you must send in a copy of your horse's registration papers with the ride entry. This copy will be returned to you the day of the ride.

### Computerized membership mailing labels offered

Joyce Calhoun is in charge of computerization of membership for Region III. She takes care of the mailing labels for the *Region 3 Newsletter* and provides labels for ride chairs and clinic organizers. These lists offer much information and can be categorized by districts, zip codes and include people who have ridden in the past two years. They can be helpful to solicit participants for all Region III NATRC events. Note to ride managers: Submit requests for rider lists with ample time for Joyce to prepare them, not at last minute, please! The fee is \$5. Contact Joyce Calhoun at 761 W.
