More news about competitors' weights and classes ruling from the national board: now, it's 0-189 lbs. for a rider (without tack) for the lightweight classes and 190+ to ride in heavyweight. A "window" of weight between 185-195 lbs. allows the rider to choose the weight class to ride in.

Also, in case you missed it in the last newsletter, all Junior competitors must now wear a helmet when competing. Ride managers, please don't forget to mention this new rule in your entry forms!

Trail Markings

Since my last column I've had lots of input from readers who share my concern for trails. The concern is pretty general in the horse community from distance riders to pleasure riders.

So what are they saying? The first concern is over loss of trails in their own areas. The second is over privatization of trails – government turning the day-to-day care fro trails over to private contractors. This has happened in California and is now beginning in Colorado. There has been talk of turning Rocky Mountain National Park over to a contractor and also a portion of the Front Range, including the south Platte area. This will mean user fees, supposedly to pay for amenities. This could affect our Willow Springs, Colorado Trail and Top of the World rides

Another concern is the "weed-free hay" issue which bans horse camping in parks unless you bring in certified weed-free hay. This policy has already caused the El Jinete ride to change its campground to the Purgatory ski area parking lot. Who knows where the trend will end?

What are horsemen doing about the problems? Many are joining groups such as Backcountry Horsemen, an organization that does maintenance on horse trails, and Colorado Horsemen's Council, which speaks for horsemen on legislative issues – they sponsored the Equine Liability Law several years ago. The San Juan Trail Riders are working with a local forest ranger to protect a trail they are in danger of losing. Parker-Elizabeth Trail Riders are trying to raise money for horse camping facilities at the Indian Peaks Campground.

Our Trails Champion award for the month goes to Ike Mosgrove and Judy Wise Mason who saw the danger to many of their local trails in the Black Forest near Colorado Springs and decided to organize a group of neighbors to work on creating, maintaining and protecting trails in that area. They held their first meeting in February, passed out flyers and called friends. They were surprised and delighted when over a hundred folks came out. Even the local paper and TV stations did features on the event. They are going great guns and will have another meeting in March.

If you know of a "Trails Success Story" like Ike and Judy's, let me know. And don't forget National Trails Day on June 3-4. Get out and do something for trails – a cleanup, or a benefit ride – use your imagination. HAPPY TRAILS!

BOARD MINUTES

The following are <u>very</u> abbreviated versions of the minutes from the last two Region III board meetings held Jan. 7 and Feb. 4, respectively.

Jan. 7 meeting – Lois Arbour, Laurie Butterfield, Joyce Calhoun, Dan Fredal, Pat Jubb, Larry Keckler, Karen Laden, Sue McKelvy, Ike Mosgrove, Dee Overholt, Nancy Reinhardt, Lisa Sowell, Judi Tobias, Jill Talbot Hicks and Susie Witter.

Treasurer's Report: Joyce contacted Bill Cumberworth to let him know to send the benefit ride money to her; \$270 received through helmet program; national board fund has \$2,540 (sans membership monies); \$400 estimated for awards. Ike has completed the audit of 1993 finances.

New officers elected – Karen Laden, President; Dee Overholt, Vice President; Joyce Calhoun, Treasurer (continued); and Nancy Reinhardt, Secretary (continued).

Safety committee: Lois reported that the safety rider packs are overloaded, discussion followed of what to keep in packs. The large camp first aid kit will be kept with Lois.

Supplies: Dee's replacement will be paid \$25 per ride and earn 250 worker points yearly. Bids will be taken for new rider vests.

Clinics: Proposed clinics discussed – Kenlyn Arabians (3/4), Tandem Park Farms (end of May).

Membership: New membership directory was discussed and will be the smaller size with a new cover color for '95. Ike will insert a national membership application form and Region III membership card in the directory and mail out by the extended Apr. 1 deadline.

Judges committee: Susie reported on committee purpose and submitted a list of '94 judges. Noted that use of apprentice judges should be encouraged.

Historian: Nancy asks that those sending photos please identify the ride, date and names of those shown.

Colorado Trail: Kathryn has ordered hats, pins and patches for workers at no cost. Money that would have gone to those items will be used for worker lunch.

Trails: Judi explained the Section 16 situation, which is likely to be lost to developers, due to El Paso discontinuing the lease. Motion passed for Region 3 to cover the expense to guarantee the lease for three years and apply for \$500 from national board. We need to encourage a more proactive role concerning trails.

Ride book: Those in touch with Sena

report things are moving along.

Miscellaneous points: Pat will continue with horse/rider points along with Judy Miller. Joyce will keep worker points.

Publicity: Karen reported on ride posters, suggestion for smaller format. There are plenty of blank ones available. Karen will investigate overlay printing of ride schedule to use up extras.

Awards: Pat will order awards soon. In other board news: Helmets mandatory for all junior riders, note to be put on ride entry forms; NATRC has a tax exempt no.; national sending a representative to the AERC convention in April; Western Horseman and Trail Blazer including blurbs about NATRC; Judges and Ride Management manuals available to everyone (note to be put in national application); rider age minimum remains at 10 years old; mileage change should be 90/60/40; Jill taking over Feedbag feature in Hoof Print; and Gene Naugle selected for honorary lifetime membeship in NATRC.

Neal phoned meeting (in accordance with conference calling rules), Kathe Hayes also called, unable to attend because of bad weather. She thought ride entry postmark rule too strict, agreement to use deadline as guideline for ride managements. Funds are available to assist SW area in tent fund project; Kathe is interested in working on the Championship Challenge committee. San Juan Valley gave up their usual cut of the

proceeds, so this is why the '94 benefit ride did so well.

Championship Challenge Ride:
Organization of ride has been difficult.
National will not back ride financially, no points will be given (discouraging many riders). Region III discussed as the area to hold it, due to the central location.
Perhaps an A ride could be put on in conjunction with it, to help financially.
Judi will chair the publicity committee, and Karen and Joyce have offered help.

Discussion of having a greater span of time between regional seminar and national convention to encourage attendance to both.

New business: Top of the World possible benefit ride. Motion passed to donate \$200 to the Colorado Horse Rescue. Frank Roybal proposes a new ride in the Rye, CO area. Sue and Dee plan to investigate.

By-law change: Motion passed to word By-laws starting at Article 1, Section 15 to read "Two conference calls will be allowed per term per member and an absence may be excused at the board's discretion."

Goal: Promote fun, education, communication and adaptability as our continuing philosophy. New 1995 goal will be to become active trail champions.

Treasurer's Report: Joyce passed out new report. Thanks to the SW area members for their contribution.

Safety committee: The first aid kits were with Bill Cumberworth.

Clinic committee: Kenlyn Arabians hosting a clinic on 3/4/95 and Cavalier Trail Riding Club clinic at the Garden of the Gods on 4/23/95.

Trail champions: Judi provided a letter regarding Section 16 as discussed at last meeting. National Board has money for trails, but the area has to hold a competitive ride on it (such as Section 16). The Cavalier Club recently voted to back up Region III on Section 16.

Membership committee: Ike reported only 52 renewals so far – keep in mind the \$15 late fee.

Colorado Trail work weekend:

Kathryn reported the trail signs need to be smaller, and not enough room for all the text. Agreement to change the signs to show the NATRC logo and the words "Maintained by NATRC Horsemen."

Public Relations committee: Discussion about ride posters to publicize rides. Printed overlays would cost about the same as reprints. 500 more posters to be printed. Discussion about putting ride booklets into clinic packets, and what to do with extra booklets after distribution. Karen and Kathe will work together to decide distribution of the posters and booklets.

Ride schedule: All rides sanctioned, thanks to everyone for working so fast. Top of the World will be the 1995 benefit ride and Kathe offered El Jinete as the benefit ride in 1996. Peaceful Valley ride cancelled.

Conference call By-law change: Motion passed to allow two conference calls per term per member and an absence may be allowed at the board's discretion. Sue will update and distribute By-laws to BOD members.

District vs. divisions: Bill Cumberworth submitted his ideas in a letter to the board. Some members feel there is a need to review the structure of the region. A work group to formed to work on this issue (see President's Message).

Four bids for vest replacements researched. Proposal was made by a 4H mother to produce 50 vests for about \$8 per vest. The CP vest color will change

to green and the numbers increased by 10, and the novice vests will be replaced in the same red color.

Supply chair position: Agreement to appoint two paid and 250-pointed (east-and west-side) supply chair positions, because historically the SW area puts together their own supplies. Coordination of shipping will be made for the rides that are some distance from the east and west core areas.

Due to overwhelming protest, the national board has rescinded the weight division rule change. Rides in 1995 will adhere to the earlier rules as used in the past. However, the issue is not dead. There is a new weight charting system to be used by all ride managers as a test this season. Laurie Butterfield will be sending forms to all ride managers.

The new sanction deadline has been successful. Region III was one of the few regions that met the deadline. New rides will be charged the standard fee, regardless of when the sanction application is sent. Also, if a ride that has been sanctioned is cancelled, a refund of the sanction can be given.

News on the Championship Challenge ride

Region 5 reports they will put together and hold NATRC's first Championship Challenge ride. It will be held either on Oct. 28-29, 1995, or Nov. 4-5, 1995, at Perry State Lake in Perry, Kan. The group has prepared a detailed report to national, and are willing and organized to push ahead with it this fall. 
