

## The Mustang Muster




**G**ood friends,

We got it all at the Region III  
Seminar in Grand Junction, Colo.,  
on Jan. 13.

Here's a roundup of the seminar's activities.

The seminar kicked-off Saturday at 1:30 p.m. with the general membership meeting. Participants listened to an update on national NATRC activities and rule changes by our national board representatives, Jill Hicks and Judi Tobias. They also presented information on trails, the proposed Region III district reorganization plan and national's study to change its shoeing requirements.

After the presentations, mem-



bers and guests sat in small groups and discussed the proposed reorganization, proposed shoeing changes and general ideas on ways to improve the sport. Generally, here is an overall look at what people said (ask your regional board representative for a more detailed written report, if you would like one).

### ***Reorganization from six to three districts***

Consensus of support with hope that this will simplify and solve representation problems.

### ***Shoeing***

Most said they would allow some shoeing changes (pads) but want standardized penalty for those competing with them. Many said they would not support corrective shoes because they indicate unsoundness. Many said they want to keep the shoeing rule as is. Others said to allow the shoeing changes, with penalty points, for novice only.

# Wake up! Get going!

## *Time to publicize*

**T**HE KEY TO GARNERING PUBLICITY FOR YOUR RIDE REQUIRES THE TWO-FOLD STRATEGY OF PLANNING AND PERSISTENCE. HERE IS A CHECK LIST OF IDEAS THAT WILL HELP GET YOU STARTED AND ENSURE THAT YOUR MESSAGE SUCCESSFULLY REACHES THE RIGHT AUDIENCE.

### ☐ FOUR TO SIX MONTHS OUT

Start early. Newcomers to the sport (please, no more "first-time riders"; it's offensive to experienced horseman) especially need time to condition and prepare.

Write a press release. Answer the who, what, when, where, why and how of both your ride and competitive trail riding. Include your phone number. Keep it to two pages, double-spaced.

Distribute the press release. Send to monthly horse publications in your area as well as the newsletters of area horse clubs, horse association, 4-H and pony clubs. Follow up with a phone call. Ask for a calendar listing as well as an article (is there a club member who could write a first-person article about the sport?). The worst that could happen is to be told no. Respond promptly to calls from interested riders.

Schedule presentations. Contact clubs that offer the highest percentages for success. (You could split this responsibility among the management team. Slide shows and videos are available to help.) Show some of the BIG national/regional awards for inspiration. Families are also looking for family activities; stress that those who don't ride still have lots of fun. Ask for volunteers. Take lots of ride flyers and NATRC information (source: regional membership chair, national NATRC office).

Hang ride posters. Contact the regional publicity chair for ride posters that are personalized for your ride. Hang them in tack and feed stores, vet clinics and large boarding barns.

Share the wealth. Give ride flyers to your veterinarian and farrier (don't forget management team members if they use other practitioners). Ask them to hand flyers to clients who are prospective competitors.

Use public sources. Riding on public land? Does that government body have a newsletter or another source it uses to inform the public about events on the property? Use it.

### ☐ TWO MONTHS OUT

Contact the weekly paper. Send the press release, make the same follow up call and ask for a listing/article.

Mail to riders. Don't forget to mail your flier to both NATRC members and non-member riders.

### ☐ ONE MONTH OUT

Contact the daily paper. Your best contacts are either the lifestyle/features editor or the outdoor editor. Think unique, unusual or something of interest to the general public when selling an article idea. (Ask if the person is on deadline when you call; ask for the best time to call back.)

### ☐ ONE WEEK OUT

Call the TV news. Contact the assignment editor of your local TV station(s). Again ask if he/she has time to talk. Think visual when you sell the idea to cover your ride. A story the day of the ride won't get you riders this year, but it will help for next year.



### ☐ AFTER THE RIDE

Write a letter. Send a "Letter to the Editor" of your hometown newspaper(s) thanking local sponsors, clubs, the sheriff's dept., Forest Service, etc., for their help in putting on a successful NATRC competitive trail ride. Because this is the best-read page of the paper, you will help create loyal volunteers as well as help publicize next year's ride.

Don't overlook sending thank you notes to specific club newsletters and well as individuals.

Again, as you prepare to publicize this year's ride, remember PLANNING and PERSISTENCE are the key to success. — Karen Laden

# WHATS ON YOUR MIND?

## We have a problem, let's get our haunches in gear!

**It was very apparent this year that we have a serious problem with membership, and so with ridership.**

Membership is down and many rides has such low attendance that there were financial problems. A couple of years of that and we will lose rides and then comes the downward spiral. 1995 was a strange weather year to be sure, but the national membership figures were down about 50 percent also.

Each of us really needs to think about how we can help and actually do something to preserve our sport. Perhaps some of the following suggestions could help:

### **Members –**

- Talk up competitive trail riding with everyone you meet on the trails. Give them information about the sport. Invite them to the next ride or clinic and make significant personal effort to get them there. Make them feel welcome. Nobody else can do this but you.
- Put on a clinic. There are lots of different ways to do this. Provide a little information so people feel more confident that they can go to a ride and not do something terribly embarrassing or harmful to their horse.
- Give a talk at a horsy function. If not comfortable with doing that, invite someone else to do it, or show one of the videos. It always amazes me that hardly anyone has heard of competitive trail riding and what a great learning experience it is.

### **Ride Managers –**

- Let's try to think of some fun things to do at the rides to loosen newcomers up and make them feel welcome. I know you are busy, but we are talking survival here.
- Maybe give a price break or special awards, etc.
- Be sure to identify first-time competitors with a badge or ribbon (and surely the rider list) and intro-

duce them on Friday night. Lavish attention, encouragement and help on these folks. Actually, is there more we can do for the novices the whole first year they are competing? Could they be assigned a companion to help them along (maybe a CP rider or someone that will be on the same trail anyway)?

- Add plentiful hints in the first-timer packets or better yet, send info out to them in advance of the ride so they have time to become familiar with what they will be doing.

### **Board of directors –**

- We have lots of good PR material, let's distribute it more freely to the general membership.
- How about some challenge awards to the ride with the most new competitors, or new competitors that become members. What about a free membership, or some other lavish gift, to the rider that sponsors the most

new members?

- Encourage clinics. Give clinic/ride participants a discount on membership. Let's have a clinic in every area where there is a ride this year.
- Find a way to make the rides more fun, social and educational. Loosen up!

Distance riding has gained enormous popularity over the past few years, proving that there are people out there on the trails. I for one would like to continue doing competitive trail riding forever. Our rides are beautiful, our people are interesting and each ride provides a learning challenge. I hope you all feel the same and if not, please let me or a board member know what changes you think would make this a better experience for you. Perhaps together, we can come up with something that clicks. – *Judy Wise Mason*

## NATRC Rule Changes Update

**I**n case you've lost track of the several amendments and rescissions to the rules that occurred over the past year, this may get you on track:

February 1995: Junior riders must wear and ASTM/SEI, Snell or approved equal equestrian riding helmet at all times while mounted from the starting line to the finishing line on each day of competition. It is also strongly recommended that adult riders also wear a helmet (although not required).

Also in February, 1995 (pertaining to a National Championship) insertion of Section VI, B., 2., f., to read "Region IA: In heavyweight, lightweight and junior classes, as horse shall be declared a National Champion when both of the following requirements are met within any three-year period retroactive to the 1994 ride year. (1) Awarded one first, (2) accumulated 36 points."

The national board was busy in February 1995: To rescind the weight change rule that passed in November 1994, then passed a new motion to

eliminate the minimum weight requirement for lightweights during the 1995 ride year. Later, in November 1995, rule Section III, B., 2. was amended to rider and tack (everything the horse carries) must weigh a minimum of 100 lbs. but less than 190 lbs. The minimum weight must be made up with dead weight, pound for pound, if rider and tack weigh less than the minimum and must be maintained throughout the ride.

July 1995 brought us a motion that regions will administer the national ballots for the national elections for the next two years, with the ballots to be returned to the nominating chairman for counting. Then, in November 1995, a new motion was passed that the nominating chairman will handle the balloting for 1996.

Also in July: No ride fees were to be charged for the Championship Challenge ride in 1995; National

## Breakfast Casserole

6 eggs	1 lb. breakfast sausage
2 cups milk	1 cup grated cheddar cheese
1 tsp. salt	6 slices white bread (no crust)

## Rule updates and upcoming projects

passed a motion that they split the profits or losses from the national convention with the hosting region, retroactive to 1995.

As for the sliding tethers issue you have been hearing about: in November we will be experiencing a "test year," not to start before June 1996. The details are going to be presented at the national Convention this coming February.

We now have a NATRC National Safety Committee, chaired by Region I's David Fling in 1996.

A few job title changes to tell you about: the formerly "NATRC Secretary" is to be referred to as "Executive Administrator" and "Treasurer, or Secretary" is now "Secretary/ Treasurer." Our former "Ride Steward" is now being replaced with "Rule Interpreter."

Some suggestions that pertain to the shoeing requirements issue: some are requesting that all restrictions be removed, or remove shoe-

ing restrictions from the novice class only. Standard penalties would be assessed for foot protection or shoe modification as well as leg protection (splint or bell boots for example). They are hoping that by doing this that riders from other disciplines will be encouraged to give it a try (while still maintaining the philosophies of NATRC). The horse scorecard is undergoing some changes to help give riders better information on how their horse's have performed. Jill has sent me a copy of what national has been working on and, since it would be crazy to use up

the whole newsletter on this one item, I will give you a rundown on what the changes are: The front is basically the same, a few minor changes in layout and administrative information (looks like a lot less advance writing for the judge's secretaries (yes!)). The back has some major work done to it that will sure make life a lot simpler. Scoring on soundness, trail ability/manners and condition has been standardized and also described. This looks to maintain a much higher level of consistency from ride to ride. We still have our little horse portraits, although they have been shrunk down to make room for all the other scads of information. It looks like they are still fine tuning, but should make for an interesting improvement.






