National NATRC is offering a program as part of a membership drive. It is challenging regions to sponsor the most new junior riders for this season.

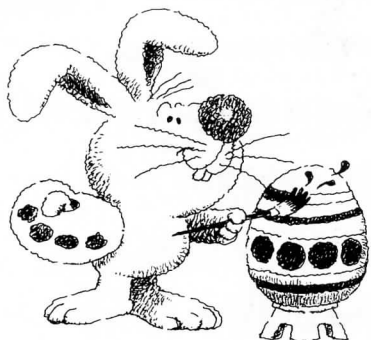

NATRC funds support trail projects

At the national board of directors meeting in Dallas this past February, the board voted to give two donations of \$500 each to trail projects. The first is at Longview Horse Park in Missouri. The money will be used to relocate the existing water line to make water more accessible to the horses when the park is used for an annual competitive trail ride held there. A horse wash will also be incorporated in the new facility.

The second request came from Sweetwater Regional Park in San Diego. The request was submitted by Lory Walls. The park is the hub of over 40 miles of a regional trail system of multi-use trails. The San Diego County Dept. of Parks and Recreation is expanding the campsites with pipe corrals, tie racks, water troughs and a wash rack. The \$500 will be used to purchase a composter for manure.

Both of these requests show the horse community's willingness to work with local government to make our multi-use open space facilities more user-friendly for equestrians.

In our own region, we have already heard that Ike Mosgrove and Judy Mason are working to create and maintain trails in the Black Forest area on the Front Range. Judy

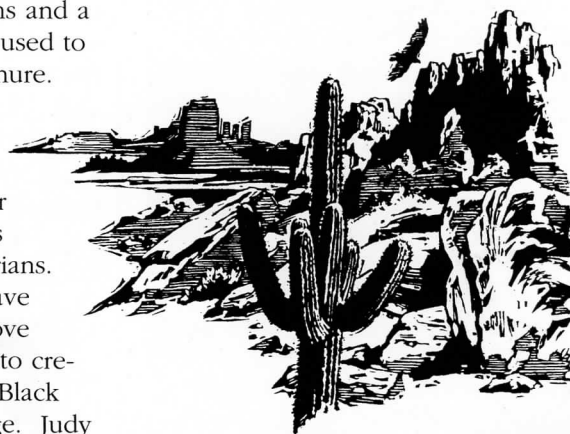
recently convinced the Colorado State Land Board to allow their group to lease Section 16 in Black Forest to prevent it from being developed. This particular area is a favorite of local residents, who enjoy its beautiful trails in the pines. Judy and Ike still have lots of work ahead of them to get enough funding to pay the lease, but they have taken a giant step in the right direction.

Isn't there a trail nearby that needs

Welcome... to the open division

When you try your first open ride, you'll find it's a whole new experience. Riders are *really* competitive (in spite of what they tell you).

1. Many open riders prefer to ride alone. The rest seldom like a group of more than two. If you want a partner, find someone before the ride starts and keep in mind it might not work out. If you come up on a single rider or two riders together, maintain some distance with them for a bit, be friendly and talk, but if they are moving more slowly than you, pass and KEEP MOVING. Most open riders hate to play leapfrog. If you find your pushing your horse to keep up, slow down and fall back.

2. Always remember *you are the driver*. If your horse likes to have company – fine, he probably has plenty back at camp. Out on the trail, you're in charge. Maintain a steady pace. An open rider dislikes having a horse charge up his horse's rear, then stay there. He really dislikes it when a rider gets in front, then slows the pace so the horse behind can catch up. Even worse is a rider who stops or waits after passing for whatever reason. If you can't follow a trail, have difficulty following the map, or have to keep readjusting tack, stay at the back of the pack. You'll make everyone happy and do much better overall.

3. "My horse has to be in front" doesn't sit well in open, even though some riders do it. If you think your horse does better at the front of the pack, no problem. Just be prepared to set a good pace and keep it for the entire ride. This does not mean you have to race, although no slow-walking horses allowed here, unless you *like* to trot all day. If riders pass you,

don't feel like you have to keep up with them (unless of course you like to blow P&Rs). Here again, remember you are the driver. If your horse hasn't learned to do what *you* want, he'd better start learning now.

4. Last but not least, a word about the famous NATRC "hole." Open riders like to find a hole in which to ride. Believe it or not, a hole can be maintained with a minute in front and a minute behind, but it takes a lot of cooperation. If everyone goes along at a decent pace, a hole can be relatively easy to achieve. Unfortunately, decent pace can mean many things. Go back and review steps one through three. If you find yourself in a nice hole, set a pace that will keep you in it. Stay well back (one to three minutes) of the horse in front of you. At the same time, stay well ahead of the horse behind you. Think this is tricky? If everyone maintaining a steady pace, then it's no trick at all. If even one rider gives up being the driver and lets his horse either dog down the trail or huff and puff and bluster his way into the horse in front, then maintaining a personal hole gets tricky for everyone.

Most important of all, relax and have fun. If you've already convinced your horse that you are the driver, you can relax and enjoy the ride. If you haven't yet convinced your horse, then there's no time like the present. It will be a little harder to relax but in the long run it will be worth it. And remember, it takes a few rides for both you and the horse to get used to a new situation. Give open more than one try. Who knows, you may be the next winner!

National BOD notes

- Guideline: Ride managers can declare **at time of sanctioning** which of two states their ride should be sanctioned in, if that ride has marked trails that cross between two different states.
- Rule change: Horse and rider shall remain in competition until such time as they are disqualified or their final veterinarian check is completed.
- Championship Challenge ride: Nov. 16-17, 1996 at Angelina, TX.
- NATRC is updating manuals for 1997.
- Rough drafts of ride books must be sent to sanction chair before Jan. 31 of each year.
- Ride management and support workers must sign two release forms *prior* to the start of each ride, one for management, one for property owners. This job can be undertaken by the rule interpreter (ride steward) on Friday if possible.
- Ride entries: add notation that ride management strongly suggests **ALL** riders wear approved helmets while mounted at the ride.
- NATRC strongly encourages management try to have ride personnel carry additional insurance coverage on their homeowners policies, if possible.
- Guideline – judges' contracts should spell out the following: The board of directors as well as local regions should adopt a resolution declaring that all volunteers, vets and independent contractors who work rides are not employees of either regional or national boards. It is clear in the Management Manuals that judges are hired by private treaty with ride managers. In light of recent litigation, the above recommendation might provide some shelter to NATRC should a judge be damaged and sue us.
- IAHA: to receive a breed recognition award (Arab and half-Arab) you must contact IAHA at (303) 450-4774 for the correct form.
- There will be national recognition of high-point CP and novice divisions starting in 1996.

REGIONAL BOARD MINUTES

Following are very abbreviated minutes from the Region III board of directors meeting on Jan. 14, 1996. Complete minutes in full detail are available from the club secretary.

Treasurer's Report: Joyce Calhoun reported there was still money due from 1995 Ride Book, so money will have to be moved from general fund to cover national board members' expenses for nat'l. convention. Karen Laden requested an accounting of expenses and list of advertisers who had still not paid from Sena.

Newly elected board officers: President Bill Smith, Vice President Dee Overholt, Treasurer Joyce Calhoun and Secretary Kathe Hayes.

National Board Report: Jill Hicks reported new board officers are President David Whitehouse,

Vice President Jim Ferris and Secretary/Treasurer Joanne Christensen. Topics included bringing ride critiques back, shoeing changes proposal and tethering. Rule change proposed about when a rider and horse remain in competition - to change from after awards to after final checkout. 1997 seminar to occur in Kansas City, Mo. Changes to be made to *Hoof Print* - more promotional material, higher quality paper stock, use of color, lack of R3's articles and shorter editorials. The new trial vet cards were discussed, much optimism that previous scoring inconsistencies in points lost will be eliminated. Ride stewards are to be known as "rule interpreters." A "judged obstacle" is now an "observation."

Membership Report: Ike Mosgrove reports 1995 was R3's lowest with only

117 members. Karen Laden agreed to take on the task of contacting those who didn't renew as to why. Discussion of use of Ride Books and flyers to give to new people for promotion. Ride Books go to members and others who competed last year. Dividing the region into three district will make for a more even split among members. Ike will see that a breakdown for six districts as compared to three will go out to members when the new directories go out prior to Mar. 15.

Clinics/Supplies: Judi Tobias reported more clinics this year, including two in Utah. Motion made/passed to give \$10 discount certificates to first-time competitors/clinic participants who could use the certificates as credit at regional rides. The ride would then be reimbursed by the region. David Fling has offered take the extra higher-numbered vests. Discussion of safety riders being required to wear safety vests for identification will left up to ride management. We will stay with the clip-on type halter tags currently in use. Gaps in the number sequences (from broken/lost tags), the Cavalier Trail Riding Club may be able to fill in the gaps from their supplies.

Motion was made/passed for Judi to purchase a video on helmets.

DEAR REGION III ...

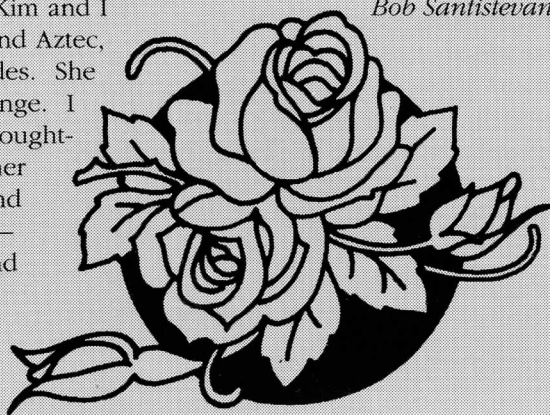

REGIONAL BOARD MINUTES

Book goes out early. Newsletter: possibility of picking up "Do you know your fellow rider" again, as well as bios on members. Kathe Hayes has offered to help out.

Horse/Rider Points: Pat Jubb suggested board evaluate the way worker points are given. The point scale is not in proportion to rider points. She will write up a proposal for the board.

Safety Riders: Lois would prefer the cooler-to-wear mesh-style safety vests – if wearing is required. National states safety riders must go through P&Rs with riders. They stay behind but have been asked to move off to the side in some instances – important to stay quiet and not disrupt competitors. Lois to screen riders so she knows who has training in CPR and first aid.

Public Relations: Karen Laden reported on articles on competitive trail riding/Larry Keckler that ran in two local papers in his area. The *Arabian Marketplace* ran article on sport also.

1996 Ride Schedule: Steve Bennett of Aurora is interested in putting on a ride in the Central City area. Jill Hicks is encouraging him to try a clinic first. Cavalier possible '96 Benefit Ride.

Karen Laden attended the national board meeting and found that R3 is the only region that requires its members to be national members in order to be able to also join the region. This was intended to support national, but it appears R3 shouldn't count on that kind of reciprocal support. Motion made to change the by-laws to remove the requirement. The message from national was to simplify things, as many of our concerns are regional only. Feelings that there should be a review of the relationship between regional and national board. If the region has to enforce rules they should expect backup support. Other issues: safety riders to follow the same rules as competitors concerning metabolic parameters and horse age; restructuring of region (too large?) and re-write of ride management manuals..

General Membership Meeting Responses: Shoeing change proposal - Karen Laden reported a number of respondents wouldn't change a thing; those who said to allow pads to take off points; and some felt NATRC's strict rules were keeping people from other horse sports away from competitive trail. Ways to improve the sport - more consistent judging; encourage new competitors to feel important, also refer to them as first-time competitors

– not first-time riders. Region redistricting – most respondents would like to see three districts be given a try.

Horse Expo on Mar. 29-30, 1996, in Denver, Colo. Discussion of items to have in booth. Jill Hicks will coordinate Friday and Sunday.

Jill had been approached by Linda Fisher from the CAHC about the region sponsoring an award for them. It was pointed out there are so many breed clubs that we wouldn't want to leave any out, tabled for later.

Regional Seminar: Neal McKinstry didn't have enough info. to give final accounting.

Next meeting scheduled for Sat., May 4, 1996 in Farmington, NM – Submitted by Nancy Reinhardt.

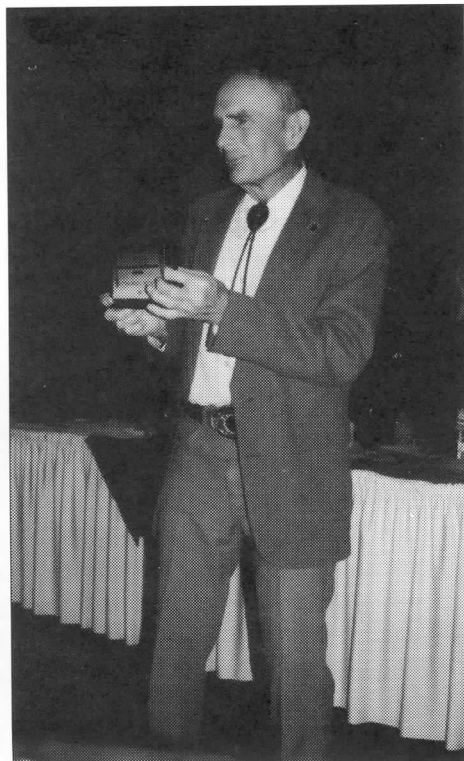
