1999 RIDE SEASON IS WINDING DOWN, BUT LOOK WHAT'S AHEAD...



While the response rate was lower than what the Board would have liked, it was pretty good considering that only a total of 152 surveys were returned of the 1,500 mailed to National members in the Aug/Sept 1998 Hoofprints newsletter, for a response rate of only 10%. We were able to gather some very useful information and comments from the survey, and we will be discussing and analyzing them at future Board meetings. I found out that the hay I bought (supposed to be grass) was alfalfa, and I had to wonder how my horse would be after a day of standing by the trailer eating it. I think in the end it was a good thing; he needed the steam.

I saddled up the morning of the ride and headed out. Right at the start we had to walk down a bank to a creek crossing. Covote Creek was only six inches to a foot deep, but it was really wide. Wider than anything near home. As a result. I had the first (but not the last) horse to refuse the crossing. So we went nearby to a better spot to cross (where there was no bank). Rhythm still didn't want to cross. He'd stand by the water, but wouldn't go in. The horsemanship judge told me to get off and lead him across. OK. Brrr. it was a cold creek I led my horse across. and he went just fine. He later crossed every creek we came to without incident and happily stood in the water to drink.

The next obstacle was backing about 7 steps between two trees (very narrow opening). My horse backed up well (we work on that a lot), but we missed the trees by a ong shot. I've got to learn to "steer" him backwards.I don't have the knack of that yet.

The next obstacle was a mount which we performed flawlessly. think I that surprised the judge, too. Hey, horse does know "something." Tip: For those of you learning, the judge wanted to see people put their left hand on the mane of the horse and their right hand on the front of the saddle, not the back. The judge said when you put your hand on the back of the saddle. you are more likely to pull your saddle sideways.

The names of the points on the map were things like "Mud Hill," "Rock Hill," etc. Then, before lunch came "Snake Hill." Snake Hill was soooo tough. It was very steep, it was muddy, it was rocky, and it zigzagged back and forth in short I thought my switchbacks. horse was going to fall down Snake Hill and kill us both, so about halfway down dismounted and led my horse down behind the drag rider. He'd never been on terrain like that even without a rider on his back, and I believe it was asking too much for him to learn to negotiate the trail with me on him. I told the judge, and he said that since I was a first-time rider on a first-time horse, it was forgiven. Yea for that!

The next obstacle right before lunch was a sidepass to a log which I haven't trained my horse to do(Istarted groundwork on it but haven't tried it from the saddle). I passed on it because I knew we weren't ready to do it; next year we'll sidepass like pros. So -2 for that obstacle. The other thing he had us do was a trot out

doing a circle in both directions after lunch and my horse did that just fine. The horsemanship judge hid in the woods and observed uphill travel and downhill travel. I did good downhill, but got a note on my card about "heavy in the saddle" uphill.

After our last p&r (we had two that day and my horse did fine on both of them), we had three miles to go. There were a few people behind me who had been detained at the p&r. I rode the last two miles with one of the drag riders, while the other drag rider waited with the others. My horse was exhausted but he was walking along OK.

We vetted out in great shape and the next day after the ride he looked good as new (no galling, sore spots, or anything). We took 3rd in our division though I am not sure if there were only three of us:-)) I was so happy just to finish and to have a very healthy horse at the end. We did this ride for experience and for training and I feel like we came out winners. Thanks to everyone who helped us along the way.

There are two more rides in this Region in October which I will try to ride in, and next year maybe we'll go from being "pretenders" to being "contenders."

why hid the judy make me do......? THE IN-HAND PRESENTATION

Why is In-Hand Presentation Important? With all competitive events, i.e., NATRC, AERC, IAHA, etc. (in NATRC you and your horse are judged) you must present your horse to the judge the day of the event at check-in. Keep in mind this is an introduction to the judge or judges. So why make a good impression?

As this introduction is executed on the ground (in-hand), every action you take with your horse affects the way you and your horse show. If you check in not paying attention to what your horse is doing, not paying attention to the safety of you and your horse, let alone the vet judge who is bent over checking your horse's legs, etc., then chances are an accident could happen. So safety is very important.

Stand on the same side as the vet judge during the examination. If the horse bolts, you and the vet are on the same side. Most horses will move away when both you and the vet are on the same side. You can imagine if you and the vet were on opposite sides what would happen if the horse decided to flee! That also is true if you are standing directly in front of your horse. Do not stand in front of your horse during the exam. Horses can run over you.

During the examination the judge's secretary records all the nicks, bites, and bumps. The judge is going to ask you to trot straight away to some point in the distance, then trot your horse in a right circle, then a left circle, and trot straight back. Why is a good presentation here important? The vet wants to see your horse's "way of going," as well as the soundness of your horse. When you ask your horse to trot, stand at the point of the horse's shoulder on the left side of the horse with your right hand on the lead rope approximately 18 inches below the halter snap and the remainder of the rope figure 8'd held in your left hand. Use a 16' lead rope. With your left hand, flick the end of the rope behind you at the rear of the horse to help push the horse into a trot. Hopefully you and your horse will start together. If your horse does not trot you will be ahead of the horse at this point. Do not turn around and look at the horse. His immediate reaction to that is to stop. You are pulling on the lead rope and looking at him and he is pulling against your weight trying to stop, which is natural for the horse to do. So don't do that!! When you start to trot, be at the point of the shoulder. That way you won't have to turn around and look at the horse. Trot straight away from the vet judge and STOP. Ask your horse to circle either left or right, then STOP. Ask your horse to circle in the opposite direction. At the end of that circle, STOP. Trot straight back to the vet.

It does not matter if you trot in hand or longe; however, longing shows your horse better. You can longe very well with a 16' lead rope with both hands on the rope. (Always think safety.) I would not use any rope shorter than 15 or 16 feet. You may use a longe line, but do not drop the remainder on the ground. Trotting away from the vet into a right or left circle without stopping and collecting your horse puts a great deal of stress on the legs, knees, and fetlock joints of the horse. So don't do that. Think of trotting your horse out in four separate actions: (1) trot straight away; (2) trot right; (3) trot left; (4) trot straight back to the judge, putting a stop in at each number. You and your horse will look organized and the horse will show better.

If you longe your horse, remember, push the horse from the rear quarters and rotate in a nice relaxed circle with the horse. Do not stand in the same spot and pivot; your circle will be too small. Remember, if your horse is "slightly off," a small circle will show this off more than a nice large circle.

Take notice of the ground your horse is trotting over. Make sure you take advantage of the smoothness of the ground. Terrain is very important when trotting the horse out for the judge. Uneven ground, rocks, or holes can make it appear that your horse is off, or lame. Also, if your horse checks in slightly off or lame, do not excuse this, commenting back to the vet, "That is his natural way of going."

In closing, if they don't have horses in heaven, I ain't going!
