## **PRESIDENT'S MESSAGE:**

This has sure been a different ride season! It was over so early. Made it hard to keep a horse in shape for the Challenge ride without the regular competitions. Obvious, we need more rides next year, as we are losing Golden Gate and Great Western will begin alternating with Strawberry. So, what are you doing about putting on a ride in your area? Seems we are really going to lack rides on the Front Range for all the members who live there. Wish we could again have that beautiful ride east of Fort Collins, Virginia Dale, and Laveta Pass always looks like excellent riding. If you know of an area and are familiar with it but don't think you have the manpower to run a ride, give me a call.

One of the things we would like to discuss at the Ride Management portion of the regional convention next March is a manpower pool. This pool could be really helpful for rides in remote areas that don't have a big base of workers, or if a key worker gets injured like Lois Hoth did this year.

Also, the GPS technology is getting so good as well as so cheap that my husband even thinks that if someone could figure out the trail, GPS and time it, then everyone could just carry a GPS and we wouldn't have to mark the trail at all! That idea might be a little in the future yet, but the trail markers could certainly ride with a GPS and the trail master wouldn't have to ride every inch several times to insure it was marked in the correct place. A group of GPS-carrying trail markers could mark the whole trail in a few days and camp over and have some fun too. Then, pre-riders could ride with a GPS and replace any missing ribbons in the correct places. E-mail now allows a ride secretary to be anywhere, or maybe even just one person could take sign ups for all the rides. Now, if we can just get hold of some of those food packets we are spreading all over Afghanistan, the judges' meals would be covered. Next, how do we handle P&R's? Remote sensing heart monitors?

These are some of the things we will be discussing at our regional convention in March. If we can think of simpler, better ways of running rides, we can make it easier for management and not burn them out, and we can perhaps have more rides in more beautiful places. I'm excited about what our combined brainpower can come up with.

Convention will also have wonderful, educational speakers that we are negotiating now. The Board decided to hold the Regional Convention after the National Convention so we could more easily distribute National Awards to our folks who can't make it to Dallas. If you are listed in the year-end standings you will get an award. Please come let us applaud you. In-region horse and rider awards will be listed in the January newsletter (including mileage and worker awards). If everybody comes who will be recognized, we will have a HUGE attendance.

Now to my pet peeve: I have mentioned several times in the past that ride management really needs to know if riders cannot make it to a ride that they signed up for. For example, at my ride, Island in the Sky, I had hired a second set of judges to allow more people to ride this year, believing we were going to have 74 riders. We had food, T-shirts, p&r workers, drivers, porta-potties, etc., assuming we would have 74 riders.

Only 59 riders showed up. NO word from the other fifteen. The cook was devastated, what to do with all the wasted food? I was crushed, what to do with the extra T-shirts, would we lose our own shirts? Then, of course, there were p&r people standing around with not enough to do, extra bales of weed free hay that had to be hauled back down the Mesa, judges feeling bad because they knew I didn't need the extra set and the large additional expense of bringing them in, etc.

I'd like to remind everyone that just because there is a deposit doesn't mean management doesn't need the rest of the entry to pay the bills. Well, for those who missed the ride, the consensus gleaned from the lovely thank-you cards indicated, "The weather was perfect...the trails were gorgeous...the judges were lots of fun and educational...p&r people were perfectly trained and incredibly pleasant...the food was excellent...T-shirts were very attractive...and so on." For those who did show, thanks for the thank-you cards. We were so depressed that the cards were really important in deciding to put on the ride again.

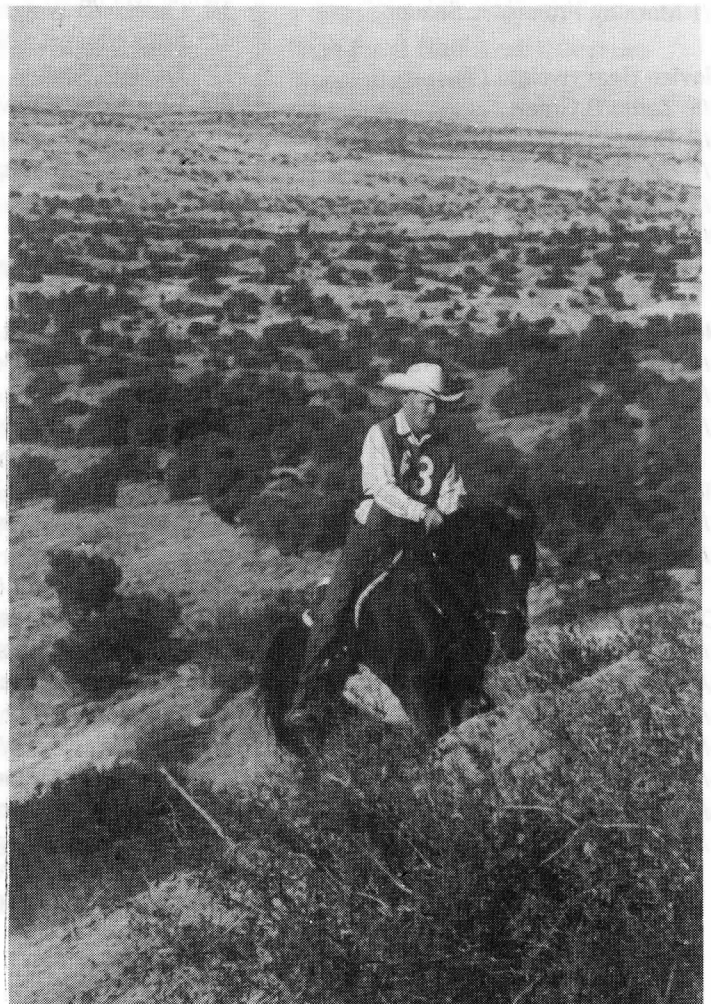

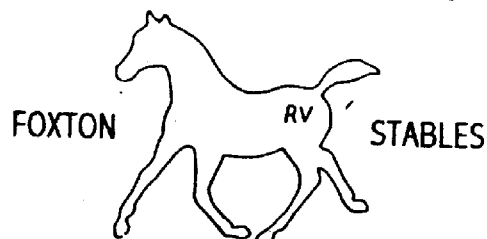
