

Region 3 Summary BOD Meeting July 10, 2005

Attendee: Kathy Brown, Tracie Scarlet, Jerry Sims, Jeff Brown, Susie Witter, Kay Gunckel, Tracey Korthuis, Sandy Hollis, Doreen Portner.

Meeting was called to order. A quorum was present to conduct business. **Minutes** were read and 3 corrections made and then approved.

Treasurer's report was e-mailed July 4, 2005 to all BOD members and we have a balance of \$4707 in our account. Still missing an invoice for expenses from Horse Expo but it will be re-created and submitted. Problem of finances discussed and BOD will keep track of expenditures and review them at each meeting. Susie W. to keep that log. BOD agreed to retain Priscilla Lindsey as treasurer for remainder of the year/term. Tracie Scarlett will send financial report on last year's seminar to BOD via e-mail. Treasurer will keep a log of outstanding rider fees to be paid in as well as other anticipated debts and expenses to be met. Kathy B. will report to BOD on financial situation from Strawberry CTR recently held.

Reports: By-Laws/Standing Rules/membership: Fees referenced are only Region 3's.

Kathy B. and Kay G. report 269 members in Reg. 3. There are 1,464 members nationally...membership is down slightly. Sue McKelvy, Editor, passed out 2005 Directories to BOD. Members will receive them with the July/Aug *Stirrup*. She did put notes on address labels reminding members who had not renewed to do so.

Juniors: Kay G. reports contact with several pony clubs in Utah, Montana, South Dakota. She'll try to arrange meetings and presentations. She is still working to get the Front Range Pony Clubs to respond to her request to talk with them about the sport of CTR. Junior Rider Manuals to be passed out to recent competitors in that class.

Awards: Tracey K. needs to order mileage glasses. Tracie S. will send out reminders to Ride Managers to promptly and accurately report Worker Points earned.

Website: Jeff B. will set up "BOD members only" address group for email communication thru the website. "Pink Book" now onsite under "Getting Started", great resource for 1st time riders.

Publicity: Iim Ward was not present but was requested to report on expenditures of the \$750 advanced to him for publicity. Ride managers have rec'd their 1/2 price ride entry forms.

Mentor: Jerry 5. reports success in their program thus far. Suggests that Ride Mgrs. have Trail Master go all the way thru maps for Novice/CP riders at the briefings before discussing Open trail variations as it would ease confusion.

Newsletter/RideBook: Sue McKelvy will retire as editor this year end. Replacment editor position is OPEN! She'll help get new editor on track for first issue or so next year. Directories are done for 2005, Stirrup will be out first of Aug. Next dead line for articles, ads, comments for Sept/Oct due Sept 25.

Nat. BOD Rept: Susie W. says Cheri Jeffcoat, President, is trying to create "buzz words" to replace verbiage that has become negative to some of us...examples "it's only a game,""first-time riders", and "dual judging". Our target NATRC age group is riders aged 35-65. She needs someone to do appreciation award write-ups. On-line registration for NATRC and CTR's as well as on-line management reporting is coming! Janice Baldwin is Chairperson...Jeff B. to aid her. Defeated proposals...horsemanship card changes, weight changes.

Region 3 Board of Directors Mtg July 10, 2005

Reports Continued:

Trails: Doreen P. says USFS charges each ride 5% of gross income, primarily rider's fees, so she will word the sale of magnets,

T-shirts differently so they are not counted in the 'gross'.

Any description of CTR using USFS public lands must declare name of the forest...i.e. Pike Nat. Forest. She feels we will be unable to use the Nat. Forest or BLM lands in the future due to impossible requirements to be met, therefore ride managers should be looking to stage rides from and on private land if possible. Trail comment cards were passed out. Laurie DiNatale attended a "Multi-user" meeting on trails and reported teaming up with Back Country Horsemen to fight unfair gov't regulations. Sharing Trails Safely with Horses pamphlet passed out to BOD members.

Manager Recognition: Doreen P. displayed items suggested for this year's recognition awards to Ride managers and secretaries. Color and logo approved as well as expense.

Horse Expo: Rocky Mtn Horse Expo expanding to West slope in Durango and Grand Junction in October. Sue Benjamin and Doreen Portner will coordinate the NATRC booth with materials from Linell Miller. Giveaways are necessary as well as volunteers to man the booth during the Expo. Start-up funds of \$200 were approved.

Safety: Sandy H. and Kathy B. say no regions responded with safety rider policies or regulations. Discussion held on whether or not a Regional policy was needed or if we can rely on National's Policy/Guidelines. BOD concerned on how to best aid CTR's in safety issues...best idea seems to be a mini-first aid kit all riders can carry to help themselves and others because often the emergency arises long before the safety riders can physically arrive to take over. Bill Smith and Farmington Fire Company have provided such kits in the past...several BOD members continue to use them! Sandy H. will pursue and try Colorado Trail CTR as a test ride for this program.

Region 3 Convention: Terri Smith will host in Farmington, NM on January 27, 2006. Topics? Suggestions are solicited..contact Terri.

Old Business:

Financial Support of Rides: Susie W. presented four senarios to this issue:

1. You can have a ride, foot the bill, keep any profits.

2. You can request \$500 start-up money and repay within 2 years.

3. You can have a region-sponsored or benefit ride.

4. You can request financial assistance after a disaster.

Susie has applications for Ride Managers. Discussion about making Chatfield a region-sponsored ride in the future...will check with Donna Johnson first. Tracie S. and Kathy B. will check this out and report back to BOD by 10/1/05.


ert for Action on Right to Ride Legislation!

Doreen Portner, our Trails Advocate, recommends Region 3 members grab a pen and paper and address letters to our local and national representatives regarding the Right to Ride Legislation. This proposed law would ensure that horses and all saddle stock have continued access to public lands where they have historically had it.

According to the Equestrian Land Conservation Resource, if a legislator hears from 4 of his constituents, it tells him which way to vote! So ask in writing, by e-mail or phone, that your legislators support or co-sponsor Senate Bill 781 and the corresponding House Bill. This needs to be done "asap" before the Bill comes up for consideration. If we don't get the bill passed, we may soon not have nearly the legal authority we need to perserve our opportunities to ride on public lands!









FLICKA'S STORY (Humor with no author from the internet)

Awards Criteria Update

Greetings Fellow Riders!

If you haven't met me, my name is Tracey Korthuis. I am your Region 3 NATRC Awards Chair. I was asked to provide a mid-year update on the criteria for year-end awards due to a possible error as listed in the Region 3 2005 Ride Book. The following is a summary of the criteria necessary for year-end awards and was taken directly from the Standing Rules:

Ruth Tyree Award - minimum of 75% of Region 3 Rides

Ken Burkdoll Award - Minimum of 75% of Region 3 Rides

Competitive Pleasure High Point - Minimum of 75% of Region 3 Rides

Novice Horse Year-end awards require a minimum of two rides and 20 points earned.

Horsemanship: Open - minimum of 30 points and 3 rides CP and Novice - minimum 20 points and 2 rides (Novice Junior has same criteria) Open Junior - no point minimum, 3 rides

To qualify for year-end awards, a horse must be owned or ridden by a Region 3 member or the rider must be a member of another Region in NATRC.

It is the responsibility of the rider to verify points and mileage witht he point secretary (awards chair) by October 15 of each year, or otherwise accept the points and mileage as calculated.

Note: We have a late ride scheduled this year, so the deadline to verify points will be October 31, 2005. Absolutely no changes will be made to awards after this date, so please verify your points, if necessary or appropriate, prior to that date. It's mid-summer already and CTR's are about 1/2 done. It is not too late to sign up for those yet to come. Review your Ride Book and do it! Your support and participation in CTR's is Ride Management's reward for all their hard work of finding, marking, GPS-ing and timing the trails presented for you to ride. It is such a privilege to see new country, encounter new terrain and ride along with friends (new and old) in partnership with your horse. What's not to like?

No ride season occurs, despite Management's attempts to control all situations, without mishaps. Our sport is one fraught with possibilities for injury and hurt. Horses are BIG animals and no one can control 100% of the outside influences such as weather, trolls in culverts, other animals and natural hazards. However, let me make a plea for common sense and courtesy. These two behaviors when engaged can turn a potentially bad situation into something manageable and pleasant for everyone. NATRC has always stood in Safety's Corner. Thinking about your horse and the space around him will prevent injuries to him, you and others. If you bring a dog along for company, please leave your canine companion at your truck or trailer safely anchored so as not to cause your neighbors a problem. Off-leash is not acceptable! Should a problem with a neighbor's dog occur during a CTR, please address the dog's owners first and, failing an acceptable resolution such as back into restraint for the miscreant, then talk with Ride Management.

Riders need to be aware that Vesticular Stomatitis (VS) has again been marking victim horses in Colorado, Arizona and New Mexico. Securing Health certificates before arriving at a CTR ride campsite is a good idea and will be required for some of our upcoming rides. Managers of CTR's are telling me "No Health Certificate-Leave the Ride" and they intend to enforce that mantra.

Weed-free hay is a requirement on all public lands! Please don't jeopardize our already rocky relationship with USFS, BLM and/or state or local authorities by bringing non-certified hay to a ride. Fines are stiff...\$500 for the first offense. The newest wrinkle is the need not only for hay bales marked with multi-colored strings but a certificate from the grower as well.

Whew! Quite a lot of warnings and advice this time. We have had several members suffer injuries at rides and just want to end that string of bad luck now. I'll hope to see you at Colorado Trail CTR soon! I do wish Milne Parish a speedy recovery from his accident at Strawberry CTR and have heard that Jan Cook has made great strides back from her head injury. We hope both these riders do well and that they will be back in the saddle riding with us soon.

Other items of interest: Kudos in advance to Terri Smith for hosting the next Region 3 Seminar at the Best Western Motel/Hotel in Farmington, NM on January 27, 2006. Make plans to attend. So far the topics of alternative healthcare for performance horses (Jim Friedly DVM) and topo map reading are on the docket, other ideas for speakers or subjects are being solicited now...call Terri with your ideas. Also, with this issue of *Stirrup* comes your 2005 directory. We lost a few members, gained new ones...we miss the ones who did not renew...come back in 2006!

I'm retiring as Editor the end of 2005...so please consider joining the ranks of editors for Region 3. I managed to muddle through in filling, albeit sloppily, Betty Wolgram's boots when I took the job two years ago. I'll be glad to assist you in production of the first issues of the *Stirrup* so don't let lack of experience daunt you. Call me or any BOD member to volunteer.

Strawberry Ride Report Richard & Leslie Lingle


Strawberry Ride - June 25-26, 2005! UTAH




