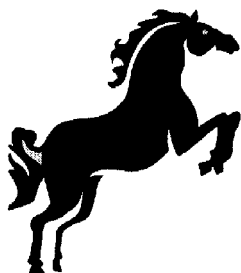

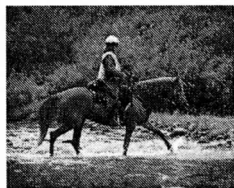

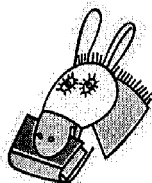
Please contact your local chapter of the back country Horseman and team up with them on their trail saving and maintenance efforts. If they aren't any efforts like these in your area, start some!

## PROPOSED RULE CHANGES

I would like to bring your attention to ALL of the Proposed Rule Changes. Please read them over considering the implications of each. Below are the ones that—in my estimation—should be given special consideration:

### CHAMPIONSHIP CHALLENGE

#2 Discontinue the CC and retire the trophy. This was brought up due to the low attendance at the CC rides in the past.

#5 If continued, these would be the rules governing the CC AND would INCLUDE CP.

### STABLING OPTIONS

#2 This would list the stabling options more clearly.

### TERMS FOR DIVISIONS

#7 Change the terms/titles for Open, CP, Novice to Division I, II, and III. The purpose would be to make the terms more 'user friendly'. Is that what it does?

### ELEVATION FROM B TO A RIDE

#9 Officially move from Guidelines to Rule Book.

### DISTANCE ONLY

#11 Change—Regular entries will NOT be allowed to displace DO entries.

#12-13 Added clarification of the DO class.

### JUDGING OBSTACLES/OBSERVATIONS

#8 Two Options

Observation—as defined in the dictionary—taking notice, gathering data, seeing---all passive activities. Would the use of 'observation' only allow judges to even give riders directions to do something?

Obstacle—implies that the judge could give directions, rearrange ribbons/logs, etc. in order to observe certain skills.

Should this clarification include one or the other or both(observation and obstacle)?

SOMETHING TO CONSIDER but not in the proposed changes. What do competitors think about reinstating awarding a buckle or blanket for National Championships and, then, eliminating the Regional Team Awards? Budget-wise . . . doing both is not feasible.

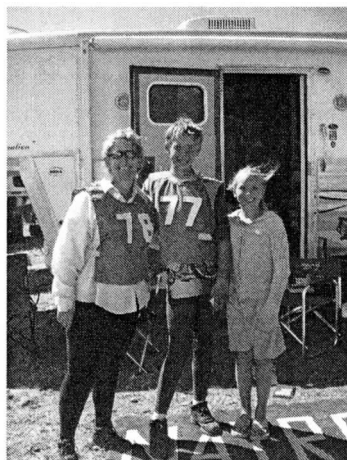

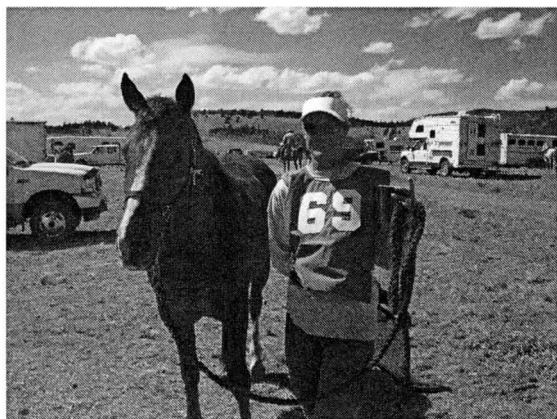

We also need to be especially aware of this sentiment *every time* we are in the back country and take extra special care to be the most sensitive users we can be (think ghost rider). ### Hiker Alert!

#### Oppose "Right-to-Ride" Bill

Horse and mule users (including commercial packstock outfits) are lobbying Congress to "grandfather" their existing stock animal uses (and abuses) of wilderness, parks, and forests. All concerned hikers are urged to contact their U.S. representative and their two senators, as soon as possible, to prevent this horrible legislation from becoming law. Your letters now will make a huge difference.

The bill (H.R. 586), called the "Right-to-Ride Livestock on Federal Lands Act of 2005," would create a new federal law that says (among other things):

"As a general rule, all trails, routes, and areas used by pack and saddle stock shall remain open and accessible for such use."

The bill could be interpreted to require the completion of expensive and time-consuming "environmental impact statements" before the land management agencies could place any new restrictions on stock use. This would make it very difficult for the agencies to close any routes to stock animals, or to limit stock numbers, even where resource damage is well documented.

#### What You Can Do:

Send a letter ASAP to your U.S. representative and to each of your two U.S. senators and ask them to OPPOSE H.R. 586. Say the following:

- 1.. You strongly OPPOSE H.R. 586 ("Right-to-Ride")
  - 2.. No user group should receive such preferential treatment
  - 3.. The agencies should be able to limit any and all uses that are damaging to public lands and/or substantially harmful to the experience of other visitors. HR 586 would only delay and/or prevent them from doing so.
- End your letter by repeating that you urge your representative or senator to strongly OPPOSE HR 586.

## Right-to-Ride Bill passes House!

### MEMORANDUM

To: AHC Recreation Organizations

From: American Horse Council

Re: Radanovich "Right-to-Ride" Bill Passes House

Date: May 17, 2006

Yesterday, the House of Representatives passed Congressman George Radanovich's "Right-to-Ride" bill (H.R. 586). The bill is intended to protect the use and access of pack and saddle stock animals on public lands, wilderness areas, national monuments, and other areas that are administered by the National Park Service, the Bureau of Land Management, the United States Fish and Wildlife Service, or the Forest Service where there is a historical tradition of such use.

The legislation would require that these federal agencies manage these lands to preserve and facilitate the traditional and continued use and access of horses to these areas.

During the debate on the legislation on the House floor, Congressman Radanovich (R-CA) stated:

"Perhaps no other activity is more synonymous with the exploration of our vast open lands than that of the use of pack and saddle stock. Who could forget those images of President Teddy Roosevelt and John Muir on horseback at what was to become the Grand Canyon and Yosemite National Parks? While some claim that this bill singles out pack and saddle use and affords it greater consideration than other forms of recreation or commercial use, I would argue that pack and saddle use has played a far greater historic role on our public lands, particularly in our western states, than simply recreation. What may be perceived by some today as recreation was once a vital part of everyday living throughout our Nation's history."

The industry must now turn its attention to the Senate bill (S. 781), which has been introduced by Senator Mike Crapo (R-ID).

### Summary Report and estimate of expenses & income for 2006

The 2006 initial estimates based on averages & committed funds were:

Income \$12,500, Expenses \$13,200, deficit \$-700.00.

For the following you can do some simple estimates on how we are doing but they might be misleading.

We are almost at the ½ way point for the year and you could simply double the income & expenses to see how we would be doing at the end of the year. That simple analysis neglects that a large portion of the regions income comes in during the summer and fall, and that some of our large expenses come in early (ride book and other printing, along with some national board).

I looked at income thus far and it is tracking reasonably well with previous years, the only concern I can see right now is we seem to be a little low in dues income (can't predict) and we don't know what we will get from the benefit.

Expenses; we seem to be doing better with the ride book and news letter (probably due to the limited number printed, and missing an issue or two). Awards are high for this year but if you track through the years that occasionally happens. National board is up for the year (there has only been 1 out of 3 meetings but expenses are already half of the average year).

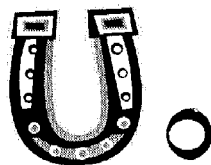
