President's Letter

on Board Director



Dear Region III,
First of all, I
hope that all of
you had a good
Christmas and a
Happy New Year.
Ours was quiet
(by choice), no
company and no
traveling. We are
VERY cold here
in Craig and it's
all we can do to
keep the water

open and the horses and cows fed and happy during our long winters. But all is well so far. Now if spring (which is June 15 for us if we're lucky) would just hurry and get here.

Next, I want to thank you for electing me to represent you on the National Board of Directors. I hope you know that I will do the very best job that I can. Please e-mail or call me with any questions or concerns you have, no matter how small, either about our region or nationally, and I will get back to you. I also want to thank Doreen Portner for the work she has done for us for the past nine years and Carla Richardson who continues to work hard for us.

I attended the National Board meeting in Denver on November 14. I was not able to be there for the entire meeting as I had just spent the past three days in Gunnison meeting with a prospective new ride manager and the BLM there, but I do want to report several things that were of concern to a number of our Region 3 members. First, the National Board is working very hard to hold down expenses and increase revenues during these difficult economic times. Other organizations are faring much worse than we are. Both membership and revenue were a bit higher as of September 30 of 2009 over the same time in 2008, but NATRC still showed a loss of approximately \$7,300. Last year NATRC lost about \$16,000, so 2009 did reflect an improvement. Reduction of Hoofprint to four issues a year saved about \$5,000.

I have faith that recovery is on the way. NATRC has had a lot to offer for almost 50 years and will continue to do so. A number of you had expressed concerns in your e-mails about the financial situation and I am pleased to report that the Board approved a Strategic Plan with five goals for 2010:

- 1) 10% increase in rides
- 2) 10% increase in competitors

The second and the second

- 3) 5% increase in members (will be measured in July)
- 4) 10% increase in revenue
 - 5) A breakeven budget

These goals are very doable. Region 3 had eight rides sanctioned in 2009; if all goes well, the region will have either nine or ten rides in 2010 and we will meet goal #1. With more rides and good turnout for those rides, we should also accomplish goal #2. In 2009 we had 330 total competitors; our goal would be to have 363. With more rides and with our members supporting our hardworking ride managers, we can easily accomplish goal #2. To accomplish goal #3, we will have to show a gain of 12 members for a total of 238. It would be wonderful (and probably

miraculous) if all our 2009 members renewed for 2010 but every organization has some attrition. Just guessing here, but if our attrition rate in Region 3 would be 10% in renewals, we would need to gain 35 new members to meet this goal. This can be done if we all do our part.

I feel that we can accomplish this gain if we all talk to new competitors and other non-members about what we have to offer, especially in Region 3, for the bargain price of \$50 single membership and \$60 family membership per year. We have a Stirrup that, thanks to Kerry Bingham, is published online at our website, sent to all members in beautiful color graphics who will receive it online, and a black-and-white printed copy mailed to the rest. We have a chat list for members only to ask questions and use for publicity and many other uses. We have wonderful year-end recognition for riders and volunteers alike.

Those of you who wrote e-mails will also be glad to know that the Judges' Committee revealed a proposed rule change for hoof protection which, hopefully, will be accepted by the Rules Committee and formally proposed to and accepted by the Board at its February meeting. After allowing the required time for comments from the general membership, voting on such a rule change could take place in November and, if passed, a new hoof boot rule would be implemented in 2011. I know that some of you wish it could be done sooner since it has been talked about for so long, but this is the process. I have heard that some have said that they will not rejoin and/or not participate in rides if it's not changed now. I can only say to everyone, "Please be a part of the solution." Be a supporter of positive change. The Board wants to get it right, not just pass a rule, as some have been passed before, and then have to go through numerous rewrites.

I presented the results of the Region 3 e-mail survey done in October which showed overwhelming support for the acceptance of all kinds of hoof boots. I also presented a proposal to allow a voluntary "booted division" for 2010 whereby riders could compete for ride awards in addition to the DO mileage, but the Board felt it might "muddy the waters" right now to add another division while considering a change in the hoof boot rule. It was, however, pointed out to me that any ride itself can offer any "additional" awards that it wishes. In other words, if a ride wants to offer one or more ride awards for horses in the Distance Only division, management is free to do so. They would just need to work it out with their judges. For example, a ride could offer a high point DO horse, or a high combined DO horse and rider, whatever. The Region 4 directors have already picked up on this idea and are encouraging their ride managers to "go for it." I will be e-mailing our ride managers to solicit their ideas and opinions. It could be a very good way to encourage more participation in DO in addition to just "riding for the mileage" whether booted or not. If you, the members, have any ideas to share,

Sorry this is so long. Please read the rest of the Stirrup carefully as there are many other important announcements that I didn't want to mix up with my president's message. This issue also contains the information on the great convention that Chuck Smith is planning for us. We would love to see it be the best attended year-end convention ever.

Spring Trail Trials

The San Juan Valley Trail Riders are hosting a "Trail Trial" in March of this year, the date being Sat., March 13, 2010 in Farmington, NM. Bill and Judy Cumberworth have again generously offered their arena as the home site. Last year's ride will serve as a basis for this years, making it a bit easier on the volunteer help. Tentative plans are being made to host the trail trial in conjunction with ACTHA. Last years trials were a good beginning but the monies earned were small. ACTHA is the new "IN" trail trials organization, handing out lots of incentives to participate. They advertise that they are, "paying you to ride your horse" by handing out ACTHA bucks which are good at any sponsorship store. Sign up 30 days in advance earn \$50, 29-20 days in advance get \$25, place 1st thru 6th earn \$150 to \$25, etc. For more details visit the ACTHA website at: http://www.actha.us/

The purpose of working with ACTHA is manyfold. First and foremost, it would pull more riders from a more widely advertised base. Through increased participation we would raise more money to improve our NATRC rides, provide incentives for ride managers and volunteers, and to defray incidental expenses associated with ride managing. Second, it may prove to be a nice jumping off point for new members in NATRC. Both organizations could end up complimenting one another; increasing interest in developing a great trail horse; get people involved in keeping, developing our horse trail systems; and adding to the horse acttivities available in our region.

The Trail Trial will consist of an 8-10 mile ride with 8 - 10 obstacles. It will also offer the possibility of an 8-10 mile recreational ride on Sunday along the NATRC trail to the West of the highway.. We need volunteers: one or two judges per obstacle, cooks & servers (ideas on breakfast and lunch), trial markers, safety riders, and other misc. helpers. NEW FOR 2010 RIDE SEASON!!

After much discussion regarding ways to help our region's ride competitors and managers, the Region 3 board has voted overwhelmingly to approve the following proposals for 2010 ride season:

- For the ride season 2010, Region 3 will give a fleece blanket to its Open Division riders who earn a subsequent National Championship on their horses. (NATRC only gives the first blanket and then gives a patch for subsequent Championships on the same horse.) The blanket will state "NATRC National Champion 2010" and the horse's name. Prices will be obtained and blankets will be purchased from the most reasonable source.
- #2 For the ride season 2010, Region 3 establishes a CP horse award as follows:

In the Competitive Pleasure Division, a horse shall be declared a Region 3 NATRC CP Champion Horse when all the following requirements are met during the Region 3 ride season:

- 1) Horse is awarded at least one 1st place and one 2nd place (or two 1st places).
- 2) Horse accumulates a minimum of 65 points.
- 3) Only Region 3 rides will count.

Region 3 will purchase a fleece blanket which will state "Region 3 NATRC CP Champion Horse" and the horse's name. Prices will be obtained and blankets will be purchased from the most reasonable source.

#3 For the ride season 2010, Region 3 will purchase Novice horse and horsemanship 1st through 6th place ribbons for each of its sanctioned rides.

Your Region 3 Board of Directors has committed itself to the goals of rewarding its members and ride managers while maintaining financial responsibility and soundness. Awards may vary from year to year depending on the Region's finances; however, the Board is dedicated to doing its best to provide incentives such as these. We would like to thank all our members and ride management for their support and for making these incentives possible.

Trail Advocacy from Doreen Portner

SHARING OUR TRAILS - A GUIDE TO TRAIL SAFETY AND ENJOYMENT

Responsible trail enthusiasts, both motorized and non-motorized, have much in common. They have an appreciation for our public lands and want to enjoy what our public lands have to offer.

In many parts of the country trails are open to and shared by equestrians, OHV riders, bicycle riders, runners and hikers. Trail sharing can and does work when people respect each other and work cooperatively to keep each other safe.

While it is important for people to respect each other on the trail, it is important to remember that equestrians are dealing not only with other trail enthusiasts' personalities, they also are working with horses whose temperaments are as individual as our own. Horses' natural instincts can influence their behaviors and affect the way they react to circumstances encountered on the trail.

For these reasons, it is important that equestrians know their horses well enough that they are confident that they will be able to control their horses when they encounter other trail enthusiasts who are allowed on the trail.

Conversely, OHV riders, bicycle riders, runners and hikers must understand that "equestrian only" trails must be respected for the safety of both the horse and rider. These trails offer the opportunity for horsemen to acclimate their horses to basic trail conditions without encountering "unknown threats" that can trigger the horse's natural instinct of flight.

When young or inexperienced horses encounter new conditions on the trail like OHVs, bicycles, runners and hikers, and even certain scents, the flight response can end with disastrous results for the horse or rider.

When equestrians on well-trained horses and other responsible trail enthusiasts meet each other on the trail the encounters can be enjoyable social exchanges if the groups understand how to work together to keep the encounters safe.

These basic guidelines will help ensure that meeting on the trail will be a safe and enjoyable experience:

Guidelines for all trail enthusiasts:

Common Courtesy

- Respect all trail restrictions and use only trails open to your mode of transportation.
- Be considerate of others on the road or trail.
- When traveling on shared use trails, continually watch for other types of recreationists.
- Slow down when sight lines are poor.
- Keep speeds low around other recreationists.
- Keep noise and dust down.
- Keep your ears open no ear buds for an IPod or MP3. Listening to headphones or ear buds can make it difficult to hear and communicate with other recreationists. In some areas it is illegal to operate vehicles or bikes with both ears covered.
- Keep pets under control. Some trails require dogs to be leashed. Be familiar with local rules

Yielding

- Yield the right of way to those passing you from behind or traveling uphill.
- Motorized vehicles yield to mountain bikes, runners, hikers, and horses.
- Mountain bikes yield to runners, hikers and horses.
- Runners and hikers yield to horses.

Greenland Clinic Needs Participants AND Experienced NATRC Riders to Volunteer!!

The Second Annual Greenland Clinic is scheduled for April 24th (Saturday) (snow date - Sunday, May 2nd) at Douglas County Greenland Open Space (just off I-25 between Colorado Springs and Denver). This clinic always fills so encourage your friends who have been wanting to try NATRC - to sign up soon (details in attached flyer).

Also we need you!!!! - - - experienced NATRC riders who would be willing to volunteer for various positions.

Douglas County has built a very nice horse obstacle course at Greenland that has about 10 obstacles that are good NATRC obstacles. We'd like to get a number of NATRC riders who would be willing to be the "judges" for some of these obstacles as we will put a "judge" at each obstacle. In a short period of time - one clinic participant can try 10 different obstacles and see how they might be judged in a NATRC ride. Prior to the clinic, we will have compiled score sheets for each obstacle to help the judges score each rider (so no need to feel that you must have judging experience - experience competing should be adequate - although we are happy to take any "real" judges!!)

Prior to the clinic participants riding the course - we will need a few NATRC riders/horses to demonstrate a good way to do the obstacle. We'll sign up volunteers and their horses for each obstacle. We envision that these demoers would then ride the trails as either point riders or safety riders.

After the riders have gone through the obstacle course - they will go out on a short 4 mile loop - with a P&R back at the start point - the "judges" can move from judging the obstacles to taking P&Rs.

With the exception of the safety riders/point riders; horses are not required - however, feel free to bring your horse as doing the obstacle course/riding the trail would be great training - and you are free in the afternoon. Greenland Open Space and the adjoining Spruce Meadows Open Space have over 30 miles of trails - mostly dirt trails with little elevation so this area makes for a good early spring ride.

Volunteers needed - - -

Registration - 1 person Food Prep (on site) and Serving - 1 person Obstacle demoers - up to 4 (I envision the safety riders/ point riders as doing the demos - each rider doing about 2 obstacles) Obstacle Judges - up to 10 Safety Riders - up to 6

Potential Obstacles (demoers needed):

Mount
Step over a log on the trail
Trot over a series of logs
Back an L shape
Side pass down a log
Turn on the hind/Turn on the haunches
Step up a series of graduated step ups
Back in hand
Put on a slicker
Open a gate
Drag a rope

Other obstacles that we probably won't use but people can try later in the day:

Cross a bridge Negotiate tires Cross a teeter totter Pull a bag of rocks out of a mailbox

Biscuit, Gravy help Budds offer carriage rides for holiday season

FLORENCE — No matter what the theme is, an old-fashioned Christmas will come alive in the height of the season in Florence.

This year will be no different when Kathy Budd harnesses Biscuit and Gravy to a decorated carriage, then picks up Santa Claus to bring him into town, where he greets children of all ages the Saturdays before Christmas in downtown Florence.



Owned by Don and Kathy Budd, "Biscuit and Gravy have both been working in harness since they were 2 years old," she said. "Now, they're 8 and 9" years old.

She was quick to point out that their neighbors, Barbara and Hubert Martinez, along with her sister, Twilla Caudron, also help them every year. The germ of an idea began when the Budds purchased Biscuit when she was 1 year old.

"She was from the Hayman fire area," Kathy said. "Those people got burned out and had to move away, so we got Biscuit. Then, we got lucky enough to find Gravy in Pueblo because they are so well matched" when it comes to size and color. Originally named Sea Biscuit because she ran fast, the Budds shortened her name to Biscuit then a year later purchased the second pony they named Gravy. Don noted that the names of the driving horses need to be different so they'll know which one the driver is talking to, he said. After finding the horses, the couple learned about a buggy, which was made by Bob Hand. When he got ready to get rid of it, he consented to sell it to the Budds. After Don installed a tongue on the wagon for the horses to pull it, the couple began to offer the service to the communities.

"We love kids," Kathy said. "The ponies are kid magnets."

Whenever the Budds take the carriage around town, the youth ran out to see them.

"The kids' eyes sparkle when they get to touch them," she said.

Not long after getting the horses and wagon, Florence Chamber board member Rudl Mergelman asked the Budds to bring their carriage to the Christmas festivities in downtown Florence. Along the way, a Penrose Chamber board member asked them to participate in the Penrose festivities, as well.

"The kids generally remember their names," Kathy said. "We tell them 'b' for brown and Biscuit is brown, and 'g' for gray and Gravy is gray. They call us the 'pony people."

The Budds also belong to the Wagonmasters Club, where Don serves as president. Kathy's involvement with horses began when she was a child, living in Iowa on the same farm as her grandparents.

"I drove big work horses with my grandfather," she said. "We fed the cattle with the big work team. I think you're born with a fascination for horses." She credits her grandfather with helping her to get acquainted with horses.

"I was his shadow," Kathy said. "He taught me how to be with horses. He gave me a lot of liberty to learn to be with horses." When she turned 3 years old, she named her first spotted pony Dolly.

Along the way, she got involved with horses in various 4-H clubs. After she graduated from high school, she moved to Wickenburg, Ariz., to work as a wrangler on a guest ranch.

"My sister says it was to be a cowboy," Kathy said. Several years later, she moved to California, where she rode a 100-mile endurance ride from Squaw Valley to Auburn.

"It took three years of preparation with the horse," she said. "I always knew my horse could do it, but I wasn't sure that I could."

But she did.


Later, she met Don on a competitive trail ride, which is a 60-mile trek in two days through the North American Trail Ride Conference.

In their spare time, the Budds compete at least once a month with trail rides, which is the first step to the national contests, which Kathy has won several times.


